## COVID-19 Interactive Data Dashboard

Please note: Reporting of laboratory test results by the Broad Institute is being impacted by two separate technology issues in their electronic process. As a result, approximately 20% of their total laboratory results were not reported in time to be included in today's dashboard. Tomorrow's dashboard data will include the 20% of data not reported today.

The COVID-19 Daily Dashboard is now available in a more interactive format. part of the surveillance testing programs.
