#### COVID-19 Interactive Data Dashboard

Please note: Reporting of laboratory test results by the Broad Institute is being impacted by two separate technology issues in their electronic process. As a result, approximately 20% of their total laboratory results were not reported in time to be included in today's dashboard. Tomorrow's dashboard data will include the 20% of data not reported today.

Updated daily by 5 p.m.

The COVID-19 Daily Dashboard is now available in a more interactive format. All of the same data previously provided is still available, including: data on confirmed and probable cases, testing, hospitalizations, hospital capacity and deaths. Some information previously shown in the weekly dashboard is also included: age groups, race and ethnicity, and sex of cases, hospitalizations and deaths; and city/town specific metrics.

This chart summarizes the counts and rates of confirmed COVID-19 cases and tests performed in MA by county over the past 14 days. Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as

part of the surveillance testing programs.
