Congregate care and long term care facilities use the County Level Positivity Rates found in this chart to determine whether a sample of staff in their facility or all staff need to be tested as part of the surveillance testing programs.

The EOHHS COVID-19 Reporting includes data on Executive Office of Health and


Human Services (EOHHS) state-operated facilities and congregate care sites.
