

\*\*Doses administered counts the number of vaccines administered; people vaccinated counts the number of unique individuals who received vaccine with valid dose numbers; doses with an invalid dose number, for example due to unresolved duplicate vaccination reports, data entry errors, dose spacing errors, or mixed manufacturers for first and second dose, will not show up in the count for persons vaccinated- it is anticipated that <1% of doses will have an invalid dose number.
