

## People Vaccinated by Demographic Group

These tables show the number of people who have received COVID-19 vaccine as reported in Oregon's ALERT IIS by race, ethnicity, sex and age group. People are grouped by rarest racial properties of the propertand ethnic identity ††. The order of racial and ethnic groups from rarest to most common for the vaccination data is: Native Hawaiian and Pacific Islander, Black or African American, American Indian and Alaska Native, Hispanic or Latino/a/x, Asian, White, then Other Race. Rarest race methodology does not have a multiracial group.

\*\*Doses administered counts the number of vaccines administered; people vaccinated counts the number of unique individuals who received vaccine with valid dose numbers; doses with an invalid dose number, for example due to unresolved duplicate vaccination reports, data entry errors, dose spacing errors, or mixed manufacturers for first and second dose, will not show up in the count for persons vaccinated: it is anticipated that <1% of doses will have an invalid dose number.

es complete differs from fully vaccinated. Series complete refers to an individual that has received 2 doses of a 2-dose series (Moderna or Pfizer) or 1 dose of a 1-dose series (Johnson & Johnson); people are dered fully vaccinated 2 weeks after receiving their second dose of a 2-dose vaccine or 2 weeks after a single-dose vaccine. Per CDC's recommendation, Individuals who have not passed the two week window after eting their series are NOT fully vaccinated and should continue taking all precautions until they are fully vaccinated.

†† Individuals contribute to only one race/ethnicity category. American Indian/Alaska Native may include data reported from the federally recognized Tribes of Oregon.
