People are grouped by rarest racial and ethnic identity of racial and ethnic groups from rarest to most common for the vaccination data is: Native Hawaiian and Pacific Islander, Black or African American, American Indian and Alaska Native, Hispanic or Latino/a/x, Asian, White, then Other Race. Rarest race methodology does not have a multiracial group.

\*COVID-19 vaccination providers must document vaccine administration in their medical record systems within 24 hours of administration, and use their best efforts to report administration data to ALERT IIS as soon as practicable and no later than 72 hours after administration.

s administered counts the number of vaccines administered; people vaccinated counts the number of unique individuals who received vaccine with valid dose numbers; doses with an invalid dose number, for e due to unresolved duplicate vaccination reports, data entry errors, dose spacing errors, or mixed manufacturers for first and second dose, will not show up in the count for persons vaccinated- it is anticipate % of doses will have an invalid dose number.

nplete differs from fully vaccinated. Series complete refers to an individual that has received 2 doses of a 2-dose series (Moderna or Pfizer) or 1 dose of a 1-dose series (Johnson & Johnson); people are considered fully vaccinated 2 weeks after receiving their second dose of a 2-dose vaccine or 2 weeks after a single-dose vaccine. Per CDC's recommendation, Individuals who have not passed the two week window after completing their series are NOT fully vaccinated and should continue taking <u>all precautions</u> until they are fully vaccinated.

th Individuals contribute to only one race/ethnicity category. American Indian/Alaska Native may include data reported from the federally recognized Tribes of Oregon. Race and ethnicity is determined by rarest race methodology described in the REAL-D implementation guide from the Office of Equity and Inclusion at the Oregon Health Authority (https://www.oregon.gov/oha/OEI/Pages/REALD.aspx pg 10,94).
