

† Series complete differs from fully vaccinated. Series complete refers to an individual that has received 2 doses of a 2-dose series (Moderna or Pfizer) or 1 dose of a 1-dose series (Johnson 8 Johnson); people are considered fully vaccinated 2 weeks after receiving their second dose of a 2-dose vaccine or 2 weeks after a single-dose vaccine. Per CDC's recommendation, individuals who have not passed the two week windou completing their series are NOT fully vaccinated and should continue taking all precautions until they are fully vaccinated.
