Note 3: Data reported to DHEC's SIMON immunization database; or the federal VAMS database. Providers have up to 24 hours to submit administration data to either system.

Note 4: DHEC's number of inventory is based on 10 doses per vial. It has been reported by some facilities that they are able to get an additional dose per vial, which can cause a utilization > 100%.

Note 5: These are administrations that were reported to DHEC's SIMON immunization database by a provider without an assigned provider identification number. DHEC is working with these providers to complete enrollment and the administrations will be added to the table once enrolled.
