# Wyoming COVID-19 Vaccine Information

Vaccination supplies continue to be limited. Because of this, W yoming is administering the vaccines in a phased approach. We are currently in Phase 1.

The image below shows which priority populations are part of Phase 1. Counties are administering the vaccines locally and are working through Phases 1a-1c. Currently, most counties are vaccinating groups that fall into 1b.

# Who is included in Phase 1 of Wyoming's COVID-19 vaccine distribution plan?



#### PHASE 1b

- Individuals 65 years of age and older
- Some frontline essential workers who interact with the public\*
- Individuals with specific medical conditions\*\*
- People on the Wyoming Medicaid Community Choices Waiver and Developmental Disabilities waivers
- Caregivers of medically vulnerable persons who are unable to get vaccinated



#### PHASE 1c

- Individuals experiencing homelessness
- Individuals who live in group settings, including prison or jail
- Critical infrastructure workers\*\*\*
- Individuals aged 50-64
- Individuals with moderate-tosevere asthma; hypertension or high blood pressure; liver disease; overweight (BMI 25-30); or Thalassemia
- Individuals living in college dormitories

\*Frontline essential workers include police, firefighters, correctional staff, funeral service practitioners, congregate care employees, healthcare providers, healthcare facility surveyors, teachers, child service providers, public transit employees, food supply chain workers, veterinarians, court system employees, and custodial staff responsible for cleaning areas contaminated with COVID-19. The following workers are also tigible if they interact with the public for more than 15 minutes and are unable to physically distance: social workers, US postal service and delivery workers, security officers, and workforce center employees.

\*\*Health conditions include cancer, chronic kidney disease, chronic betructive pulmonary disease, solid organ relands, sickle cell disease, down syndrome pregnancy, diabetes, heart conditions, obesity (BMI over 30), immunocompromised state from solid organ transplant, blood or bone marrow transplant, limune deficiencies; long term high dose corticosteroids; or other immune weakening medicines; and severe neurologic conditions (including motor neuron disease, myasthenia gravis, multiple sclerosis, Parkinson's disease, erebral palsy, quadriplegia or hemiplegia, progressive cerebellar disease, epilepsy, stroke and dementia).

- Vaccines are currently available in **limited supply** (though supply is steadily growing).
  - Because of this, Wyoming counties are vaccinating in phases (en Español).

#### • The vaccines are FREE.

- If you have insurance, your insurance can be billed for administration fees. No fees will be billed to you.
- If you do not have insurance, you will be able to get the vaccine and no fees will be billed to you.

#### • The vaccines are SAFE.

- CDC has safety information and guidance to help you prepare for your vaccination.
- The authorized vaccines require two doses for maximum effectiveness.

First Vaccine Doses Received: 124,220 (57,720 Pfizer/60,500 Moderna/6,000 Janssen)

First Vaccine Doses Administered: 100,698

Second Vaccine Doses Received: 81,725 (41,925 Pfizer/39,800 Moderna)

Second Vaccine Doses Administered: 59,695

Reporting of administered doses is up to 72 hours behind. Counts do not include federal doses provided separately and directly for tribal, VA, and military facilities.


