#### Situation Summary

In December 2019, a new (or novel) human coronavirus (SARS-CoV-2) type emerged in China. At this time, it's unclear how easily this virus is spreading between people. Patients with confirmed COVID-19 infection have reportedly had mild to severe respiratory illness with symptoms of fever, cough, and shortness of breath appearing anywhere from 2 to 14 days after exposure. 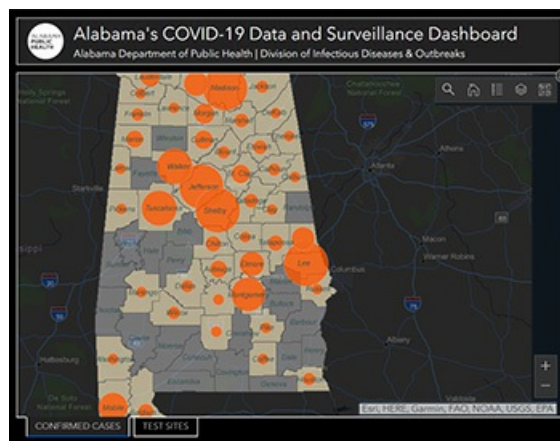
#### Current Situation in Alabama

\*Total tested primarily represents tests that were satisfactorily performed by the Alabama Department of Public Health (ADPH) Bureau of Clinical Laboratories (BCL), along with some data from commercial labs. Commercial labs are required, by law, to report positive tests to ADPH. Some commercial labs do not report negative specimens.

\*\*Testing sites are facilities who have reported to ADPH that they are collecting specimens for COVID-19. This map does not reflect all collection sites in Alabama.
