Situation Summary

In December 2019, a new (or novel) human coronavirus (SARS-CoV-2) type emerged in China. At this time, it's unclear how easily this virus is spreading between people. Patients with confirmed COVID-19 infection have reportedly had mild to severe respiratory illness with symptoms of fever, cough, and shortness of breath appearing anywhere from 2 to 14 days after exposure. 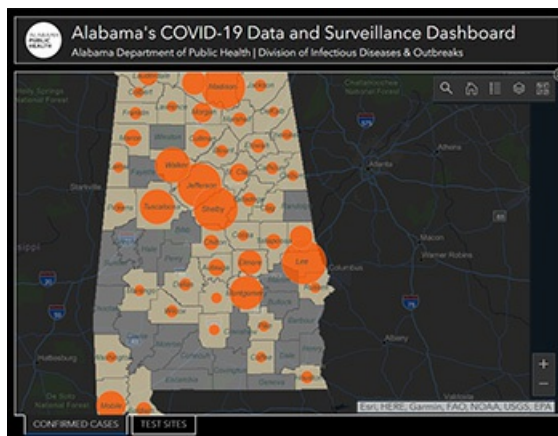

Case Characteristics as of April 11

Total Tested primarily represents tests that were satisfactorily performed by the Alabama Department of Public Health (ADPH) Bureau of Clinical Laboratories (BCL), along with some data from commercial labs. Commercial labs are required, by law, to report positive tests to ADPH. Some commercial labs do not report negative specimens.



Reported Deaths and Died From Illness on the dashboard represent the number of individuals who have a positive lab result and are now deceased. To count a person who died from COVID-19 disease, the medical record of the deceased person has to be reviewed by a physician and Infectious Disease and Outbreak staff. Once review is complete, if the death is attributed to COVID-19, the individual will also appear in the Died From Illness on the dashboard.
