Number Tested: 639

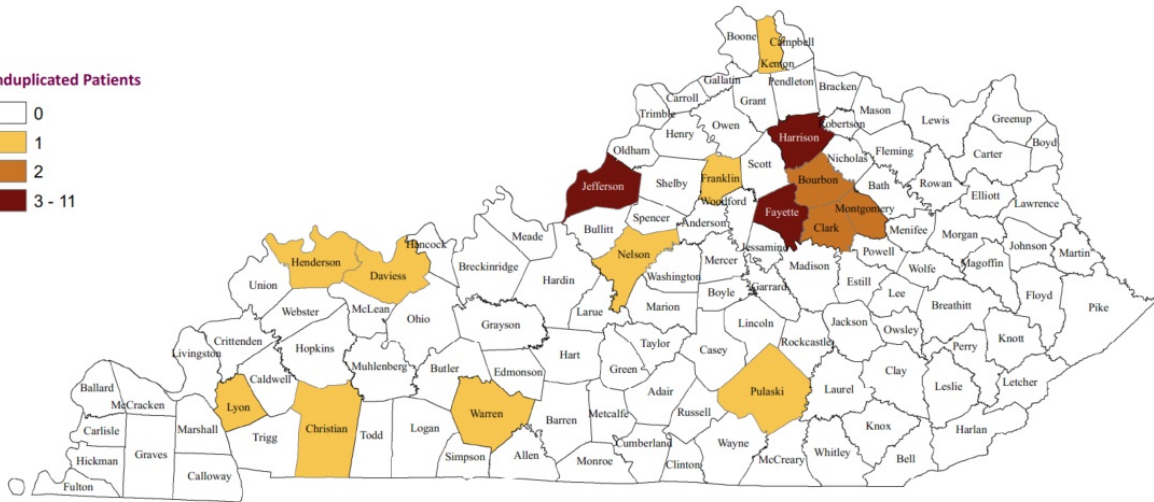
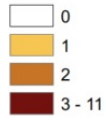

Unduplicated Patients

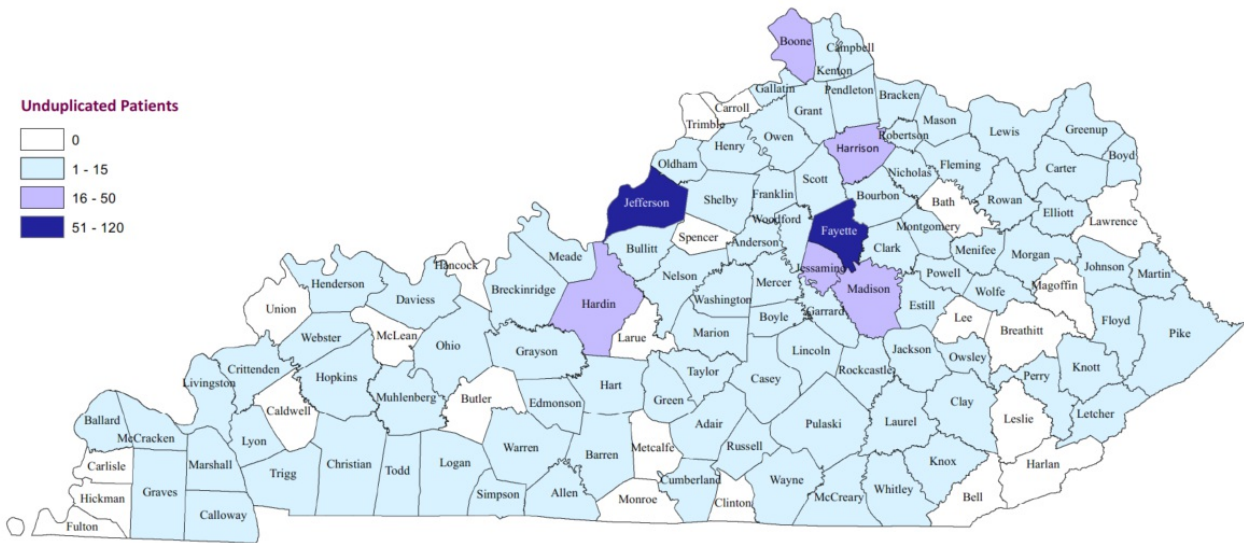
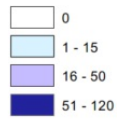
