Daily and cumulative reports on Massachusetts COVID-19 cases, testing, and hospitalizations. Weekly and biweekly reports include nursing facility data, cases by city/town, residents subject to COVID-19 quarantine, and data from State facilities.

• Weekly COVID-19 Public Health Report - September 9, 2020

The Weekly Public Health Report includes enhanced, more granular information to be updated on a weekly, or biweekly basis.

This data includes:

- Contact tracing cases and outreach
- Individuals released from isolation (recovered)
- · Cases and case rate by age for last two weeks
- Probable cases
- Cases and deaths in Long Term Care Facilities
- Infection control survey results at nursing homes
- PPE Distribution

COVID-19 Community-Level Data Map

The Community-Level Data Map shows each Massachusetts city or town designated as a higher risk, moderate risk, or lower risk community. Each risk level is based on the average daily COVID-19 cases per 100,000 residents, as indicated in the Weekly COVID-19 Public Health Report.

COVID-19 Weekly State Facility Report

Updated each Wednesday.

EOHHS COVID-19 Reporting

The EOHHS COVID-19 Reporting includes data on Executive Office of Health and Human Services (EOHHS) state-operated facilities and congregate care sites.

This data includes:


- Total residents/patients and staff as well as COVID-19 positive patients/residents and staff at EOHHS state-operated facilities
