# **COVID-19 Response Reporting**

Daily and cumulative reports on Massachusetts COVID-19 cases, testing, and hospitalizations. Weekly and biweekly reports include nursing facility data, cases by city/town, residents subject to COVID-19 quarantine, and data from State facilities.

### **COVID-19 Weekly Public Health Report**

• Weekly COVID-19 Public Health Report - October 7, 2020

The Weekly Public Health Report includes enhanced, more granular information to be updated on a weekly, or biweekly basis.

This data includes:

- Case and testing information by city/town
- Contact tracing cases and outreach
- Individuals released from isolation (recovered)
- · Cases and case rate by age for last two weeks
- Probable cases
- Cases and deaths in Long Term Care Facilities
- Infection control survey results at nursing homes
- PPE Distribution

#### **Community-Level COVID-19 Data Reporting**

Updated weekly, following publication of the Weekly COVID-19 Public Health Report

#### COVID-19 Community-Level Data Map

The Community-Level Data Map shows each Massachusetts city or town designated as a higher risk, moderate risk, or lower risk community. Each risk level is based on the average daily COVID-19 cases per 100,000 residents, as indicated in the Weekly COVID-19 Public Health Report.

Communities Not Designated Lower-Risk

This page lists communities that are **not** designated as lower-risk communities. These communities are not permitted to move into Step II of Phase III of the Commonwealth's reopening plan. Lower risk communities are defined as cities and towns that have not been a designated in the "red" category in any of the last three weekly Department of Public Health weekly reports.

Updated each Wednesday.

EOHHS COVID-19 Reporting

The EOHHS COVID-19 Reporting includes data on Executive Office of Health and Human Services (EOHHS) state-operated facilities and congregate care sites.

This data includes:

- Total residents/patients and staff as well as COVID-19 positive patients/residents and staff at EOHHS state-operated facilities
- Total residents and staff as well as COVID-19 positive residents and staff at congregate care sites under the Department of Developmental Services, Department of Children and Families, Department of Mental Health, Department of Public Health, Department of Youth Services, the Massachusetts Commission for the Blind, and the Massachusetts Rehabilitation Commission.
- EOHHS mobile testing program data
- Department of Corrections onsite testing data
