The information is aggregated by health system for those hospitals that are part of a health system. This is because systems are centrally tracking and distributing personal protection equipment (PPE) amongst their various facilities and looking at patient surge and load from a system perspective. Non-system hospitals are identified as individual hospitals.

#### **DATA DICTIONARY:**

**PPE Days on Hand** - This is a calculation based on a number of factors including the amount of PPE, the number of COVID-19 patients, beds, industry standard usage and conservation techniques.

**COVID-19 Patients** – Confirmed positive patients, as well as patients who are currently pending and under investigation (PUI). This includes COVID-19 patients in the ICU.

**COVID-19 Patients in ICU** - Confirmed postive patients and suspected patients in intensive care unit (ICU).

**Bed Occupancy** - The percentage of staffed inpatient beds occupied by any patient regardless of COVID-19 status. This includes surge or overlow beds.
