### **Previous Clinical Variables:**

- # of ED Discharges The number of patients discharged home (or equivalent) from ED with suspected or confirmed COVID-19 in past 24 hours. INCLUDE hospital urgent care and ED drive through.
- **# in Critical Care -** The CURRENT number of patients in critical care units with suspected or confirmed COVID-19. INCLUDE non-critical care areas being used for surge critical care. DO NOT INCLUDE ED boarding/overflow (patients currently admitted and awaiting bed).
- # on Ventilators The CURRENT number of patients receiving mechanical ventilation with suspected or confirmed COVID-19. DO NOT INCLUDE ED boarding/overflow (patients currently admitted and awaiting bed) and surge critical care areas.
- # of Inpatients The total number of positive tests for COVID-19 among admitted patients.

### **New Clinical Variables:**

**Previous Day's COVID-19-related ED Visits** (Enter the total number of ED visits who were seen on the previous calendar day who had a visit related to COVID-19 (meets suspected or confirmed definition or presents for COVID diagnostic testing – do not count patients who present for preprocedure screening).)

Total hospitalized pediatric suspected or confirmed positive COVID patients (Patients currently hospitalized in a pediatric inpatient bed, including NICU, newborn, and nursery, who are suspected or laboratory-confirmed-positive for COVID-19. Include those in observation beds.)

### **DATA DICTIONARY:**

**PPE Days on Hand** - This is a calculation based on a number of factors including the amount of PPE, the number of COVID-19 patients, beds, industry standard usage and conservation techniques.

**COVID-19 Patients** – Confirmed positive patients, as well as patients who are currently pending and under investigation (PUI). This includes COVID-19 patients in the ICU.

**COVID-19 Patients in ICU** - Confirmed postive patients and suspected patients in intensive care unit (ICU).

**Bed Occupancy** - The percentage of staffed inpatient beds occupied by any patient regardless of COVID-19 status. This includes surge or overlow beds.
