The case count for Sanilac County was reduced by 1 as it was determined the case was double counted when reported to the Michigan Disease Surveillance System.

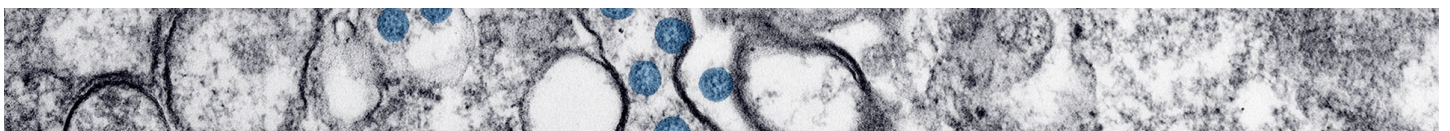
