MSDH is actively working with doctors and hospitals to quickly identify cases and respond effectively to limit this outbreak.

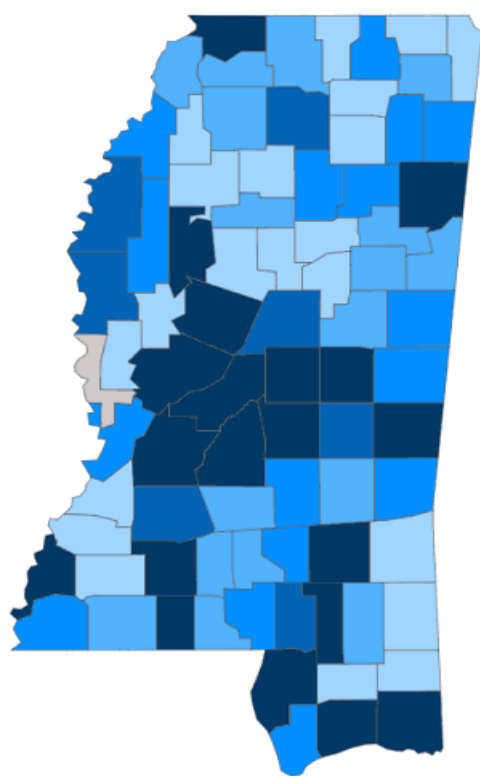
Mississippians are advised to take health precautions to prevent the transmission of disease, and stay in touch for the latest information on the situation in Mississippi.

## Long-Term Care Facility Cases and Deaths

Long-term care (LTC) facilities like nursing homes are considered high risk locations because their residents are older or in poor health. Even one case of COVID-19 in these facilities among residents or employees is considered an outbreak. We investigate residents, staff and close contacts of infected individuals for possible exposure. (Long-term care facilities include nursing homes, intermediate care facilities for individuals with intellectual disabilities, personal care homes, assisted living facilities, long-term acute care facilities, and psychiatric or chemical dependency residential treatment centers.)

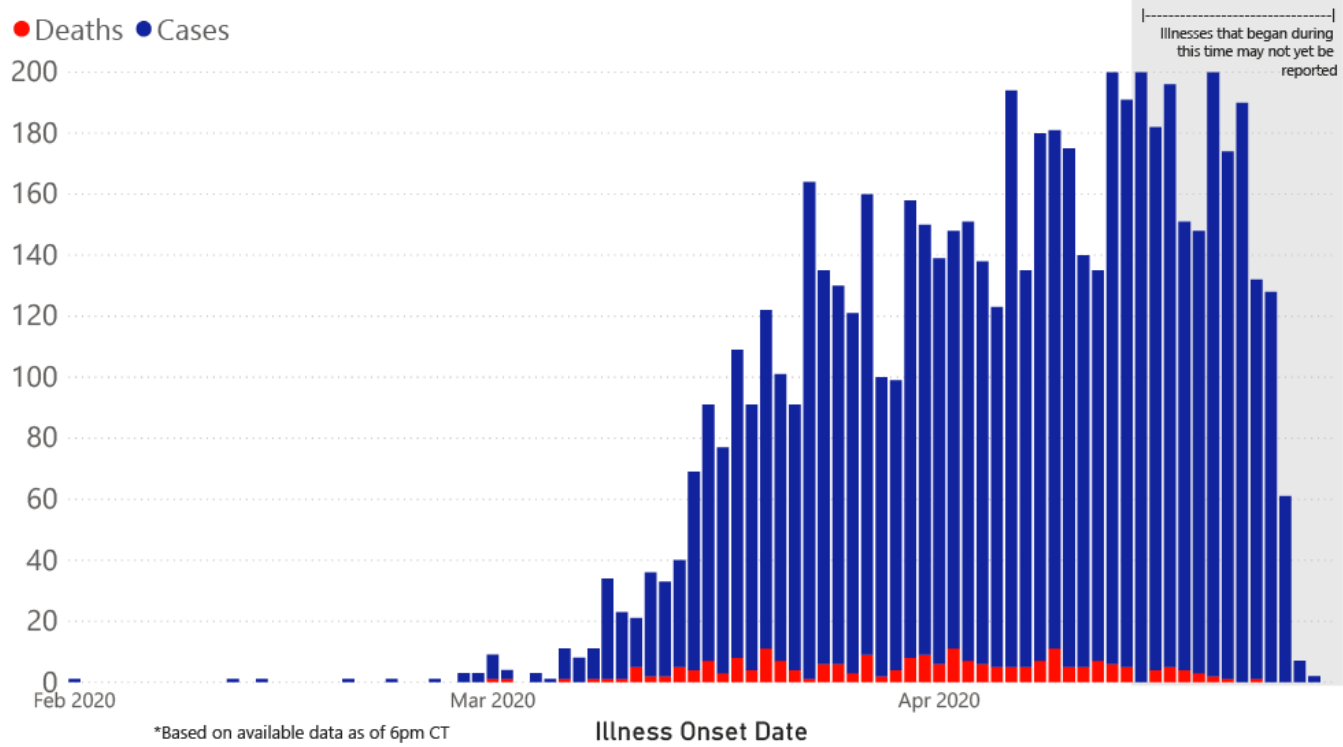

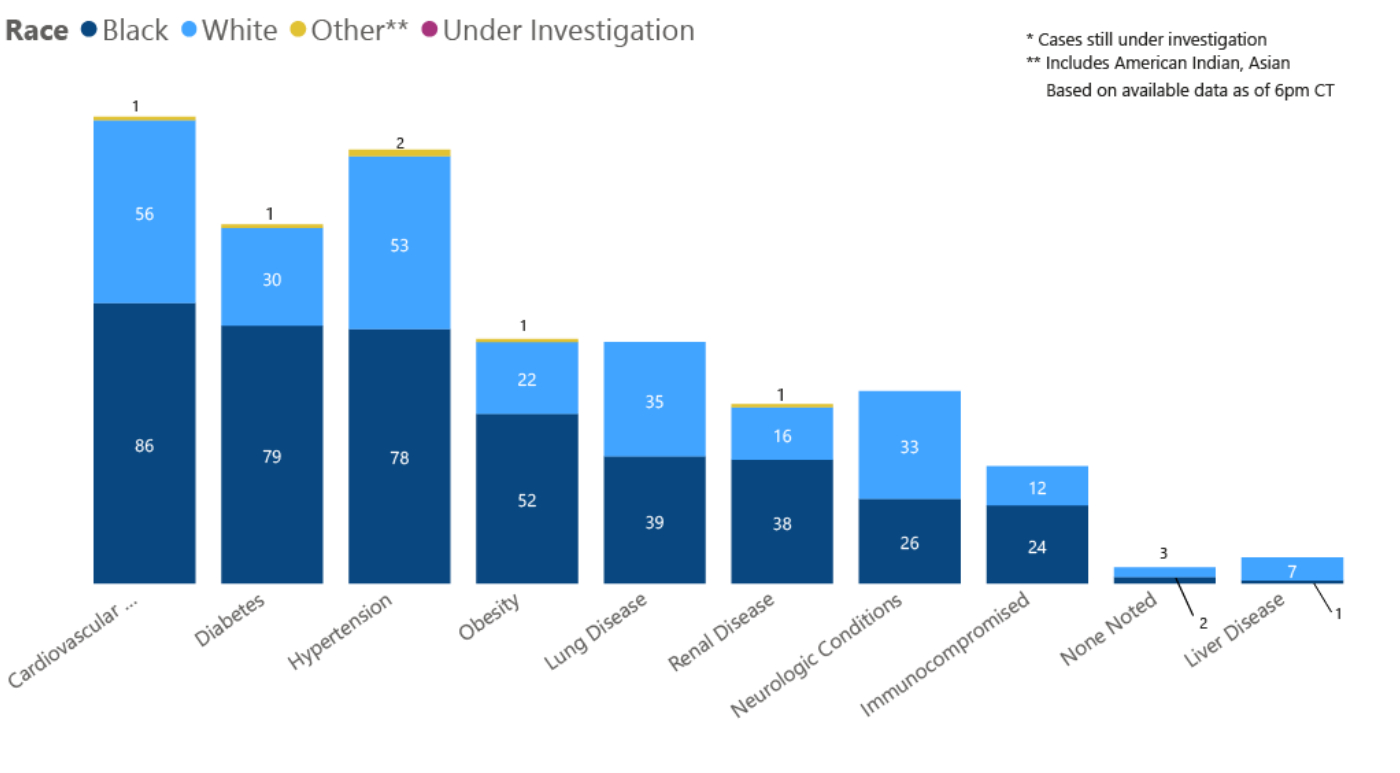

## COVID-19 Cases and Deaths by Date of Illness Onset through April 28, 2020\*, Mississippi

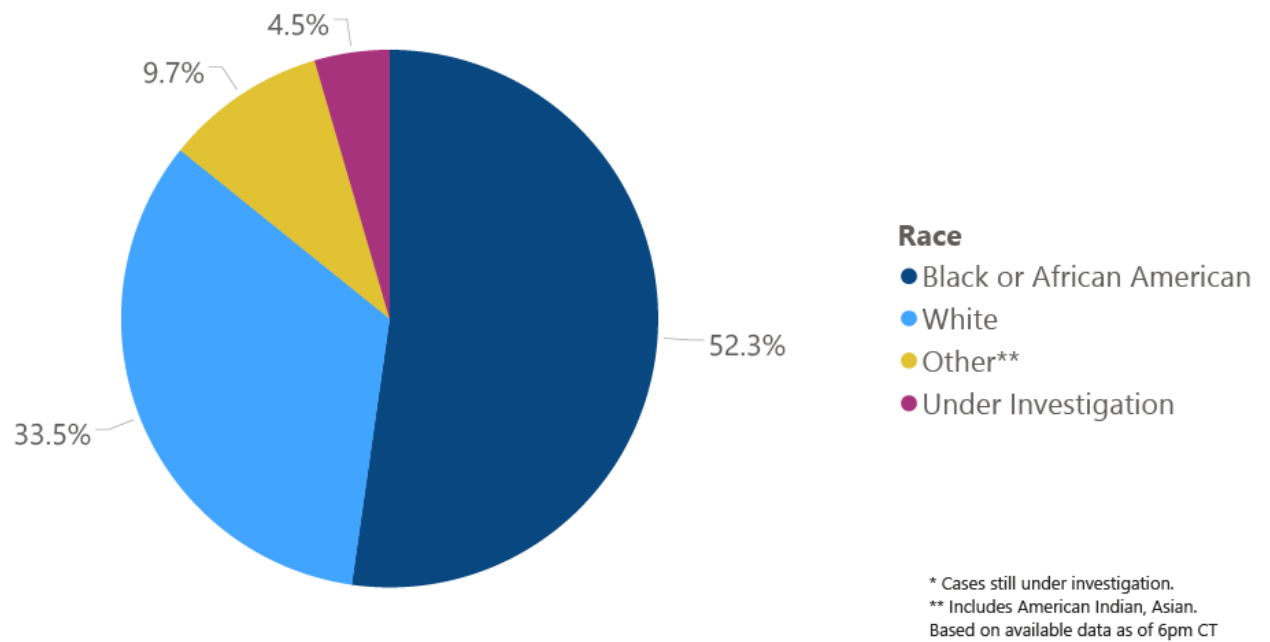

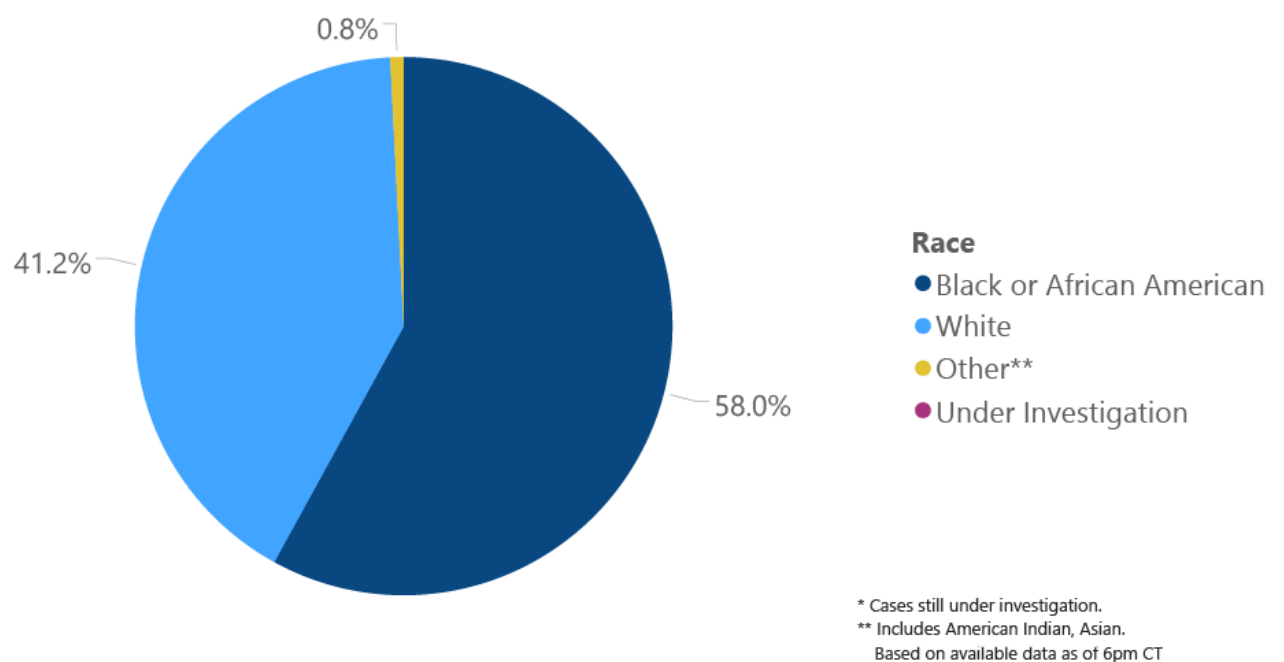
## COVID-19 Underlying Conditions in Deaths by Race through April 28, 2020\*, Mississippi



## COVID-19 Cases by Race through April 28, 2020\*, Mississippi



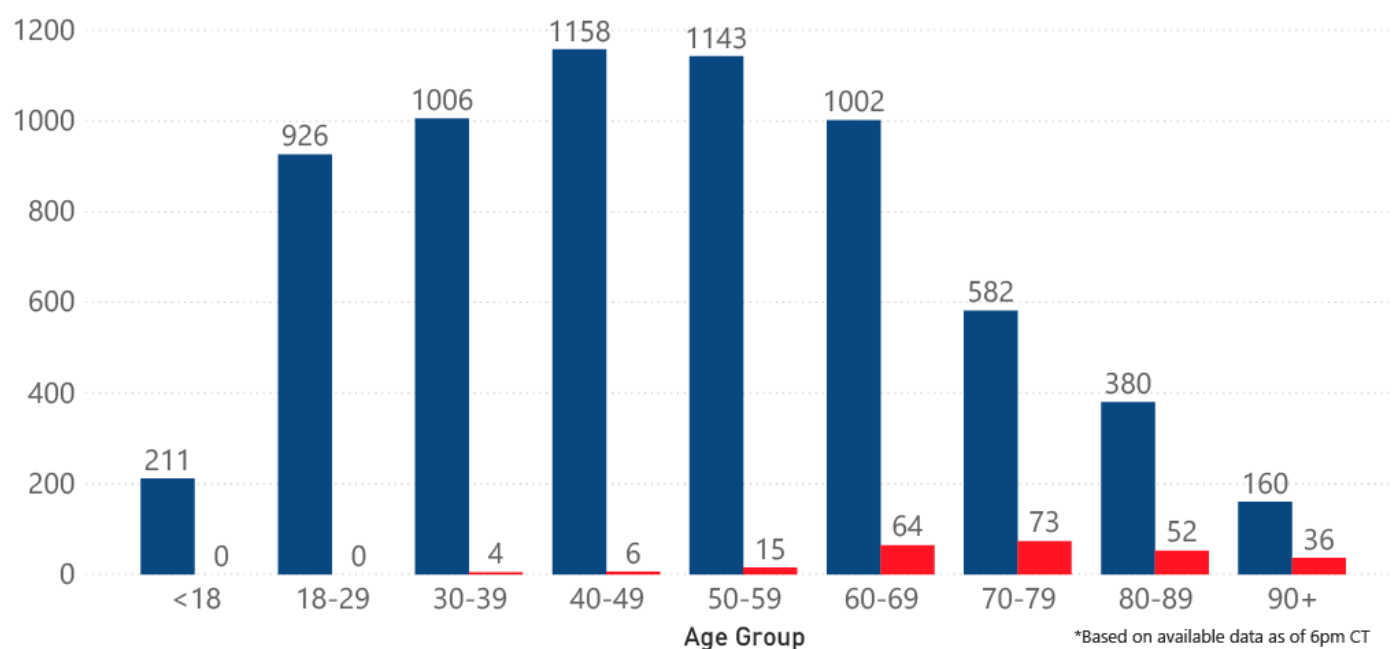
## COVID-19 Deaths by Race through April 28, 2020\*, Mississippi



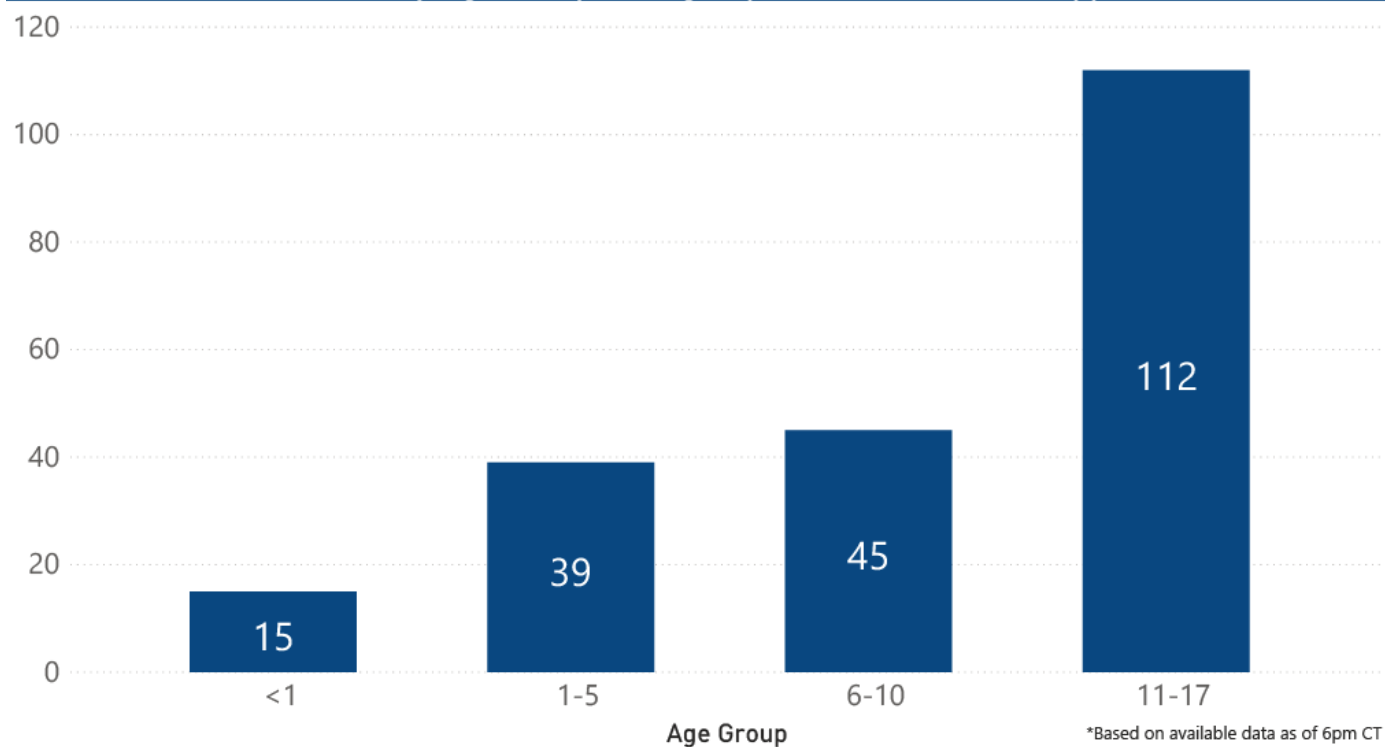


## COVID-19 Cases and Deaths by Age Group through April 28, 2020\*, Mississippi

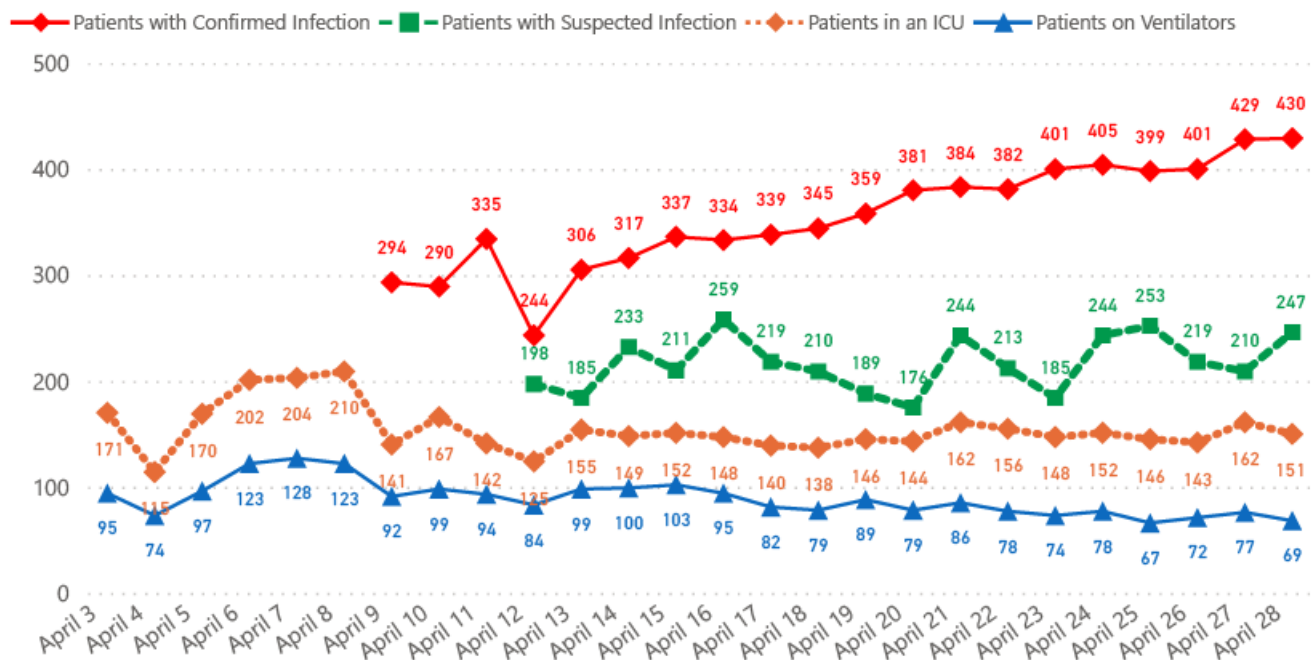

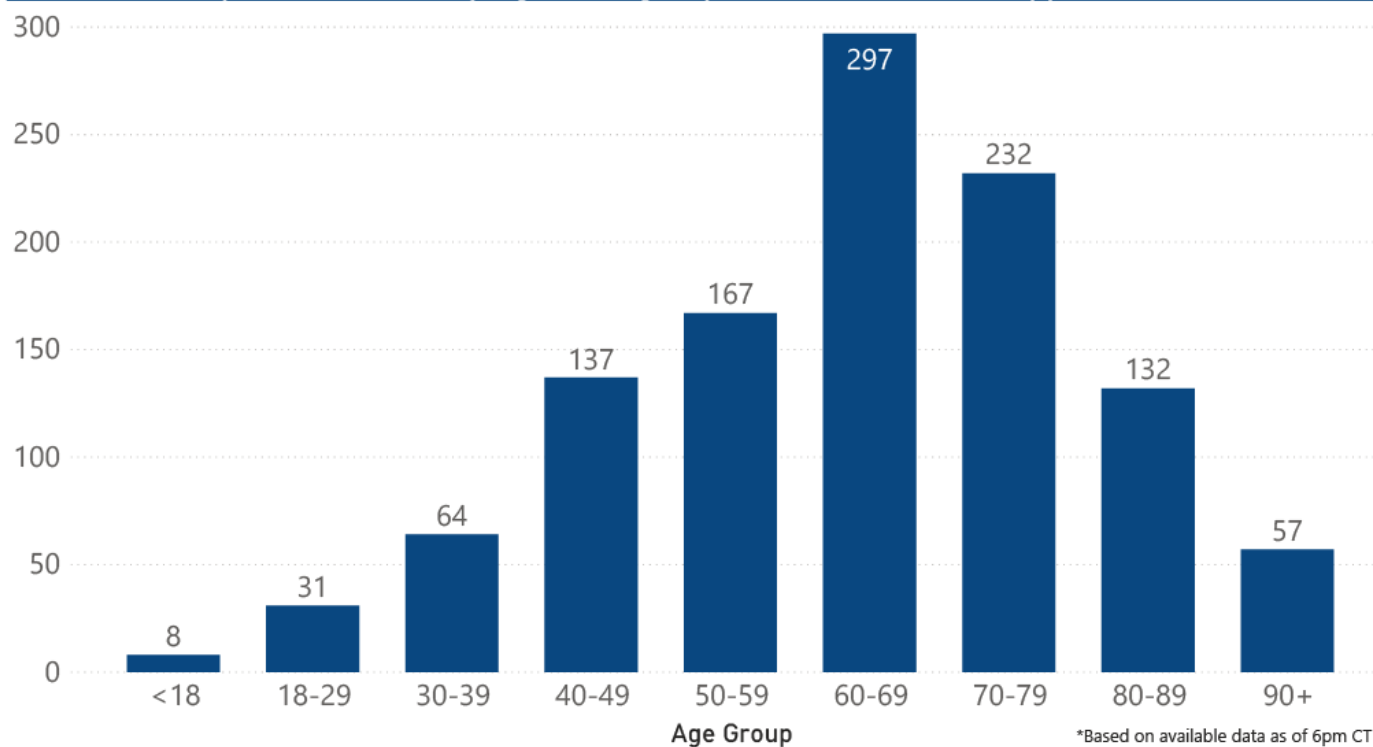
## COVID-19 Pediatric Cases by Age Group through April 28, 2020\*, Mississippi



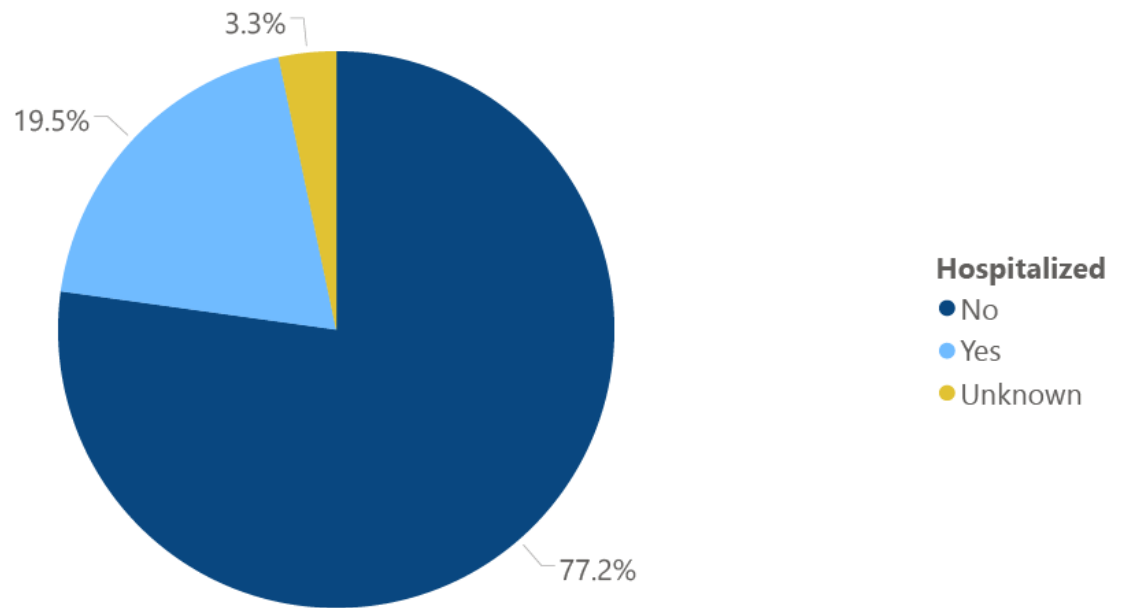
## COVID-19 Hospitalizations Reported by Mississippi Hospitals\*



## COVID-19 Hospitalized Cases by Age through April 28, 2020\*, Mississippi

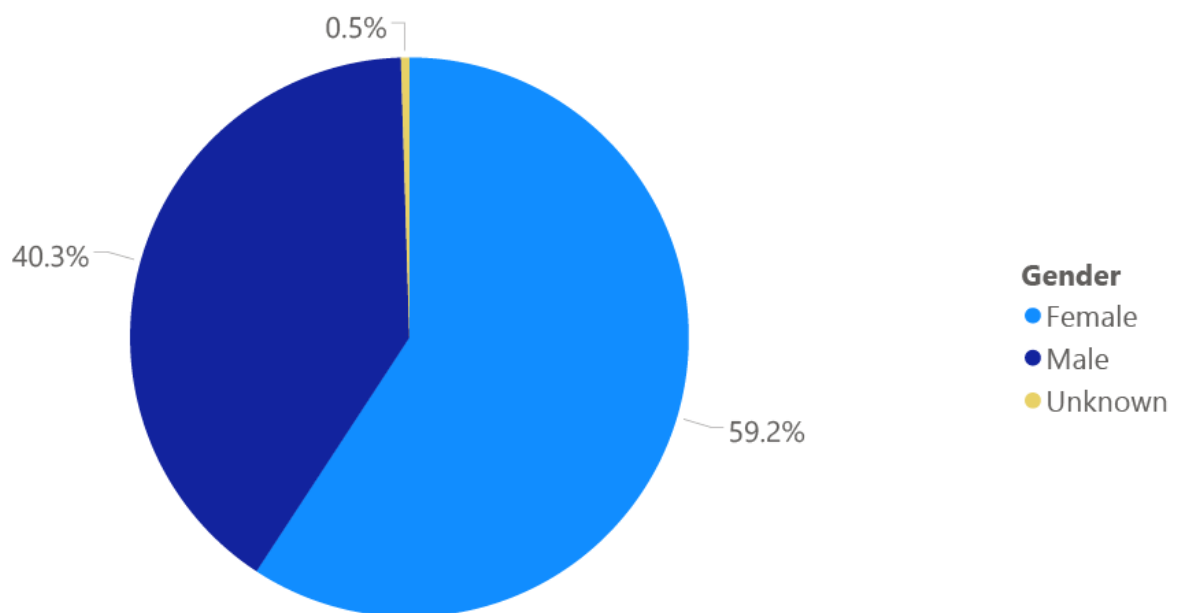


## COVID-19 Cumulative Hospitalizations-Investigated Cases April 28, 2020 \*

## COVID-19 Cases by Gender through April 28, 2020\*, Mississippi

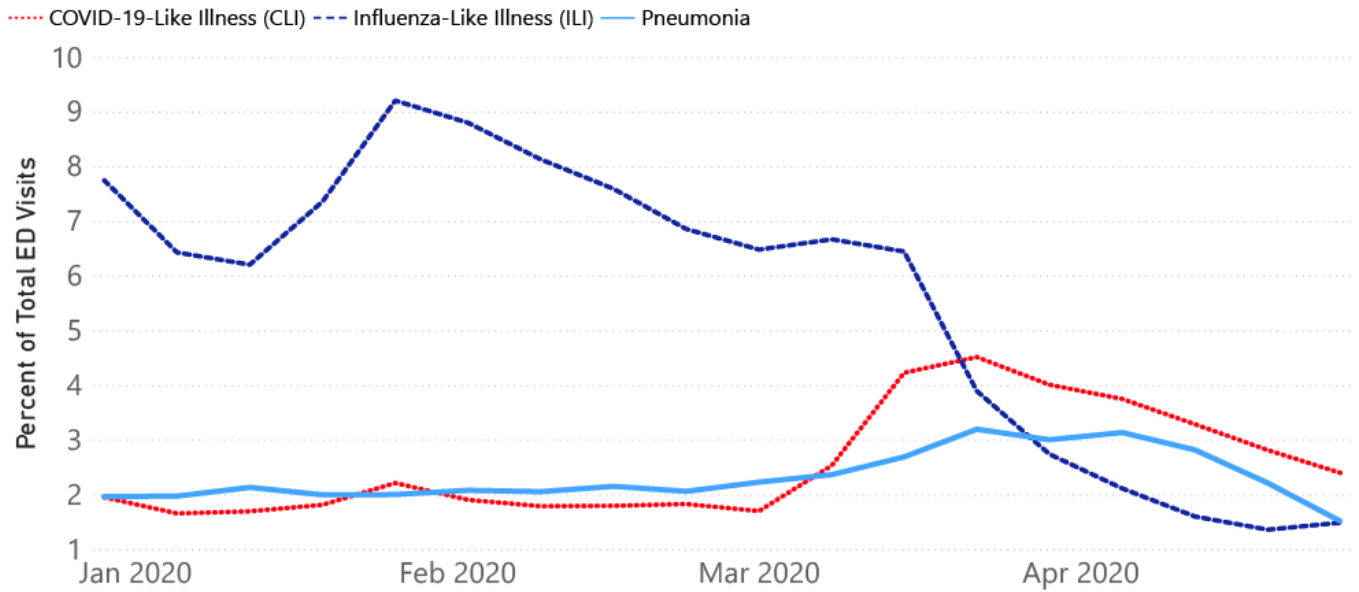

# COVID-19 Testing

## Statewide Combined Testing Summary

COVID-19 testing providers around the state include commercial laboratories as well as hospital labs. Combined with testing done by the MSDH Public Health Laboratory, the figures provide a complete picture of all Mississippi testing. We will update these figures as data becomes available.

Combined testing totals (MSDH, hospital laboratories and commercial testing providers) as of April 28, 2020.

## MSDH Testing Summary

MSDH Public Health Laboratory (MPHL) testing totals as of 6 p.m., April 28, 2020. These totals are for tests performed at the MPHL only.

- Total individuals tested by the MPHL: 12,335
- Total positive individuals from MPHL tests: 1,462

## Getting Tested for COVID-19

The MSDH Public Health Laboratory, its partners, and private providers are testing statewide for COVID-19.

Anyone with symptoms of fever, severe cough or severe chest pains – especially those who are older or in poor health – should make arrangements for testing with their doctor or one of the many healthcare providers now performing testing. Healthcare providers can assess your health history and symptoms, and perform testing for COVID-19 as needed. MSDH is also helping conduct free drive-up testing sites in many parts of the state. Always call ahead to the testing provider for instructions on safely being examined before you visit for your test.

## What MSDH Is Doing

The Mississippi State Department of Health is aggressively responding to the rapidly evolving COVID-19 situation. With other state agencies, it has activated emergency operations in order to slow the spread of COVID-19 in Mississippi.

Other steps that MSDH is taking include:

- Surveillance: Increasing surveillance (monitoring) activities to identify cases of COVID-19 as quickly as possible and to limit person-to-person transmission.
- Testing: Making COVID-19 testing available for healthcare providers through the MSDH Public Health Laboratory.
- Planning: Working directly with hospitals and healthcare providers across the state to plan for possible cases of COVID-19, preparing them to identify and safely treat cases.
- Readiness: Assessing statewide hospital capacities, ensuring the capacity of the MSDH Public Health Laboratory for COVID-19 testing, and informing all Mississippi healthcare providers about procedures for identifying and testing for coronavirus cases.
- Information: Providing guidance to business, education and other entities on how to respond to the possible spread of COVID-19 in the community.

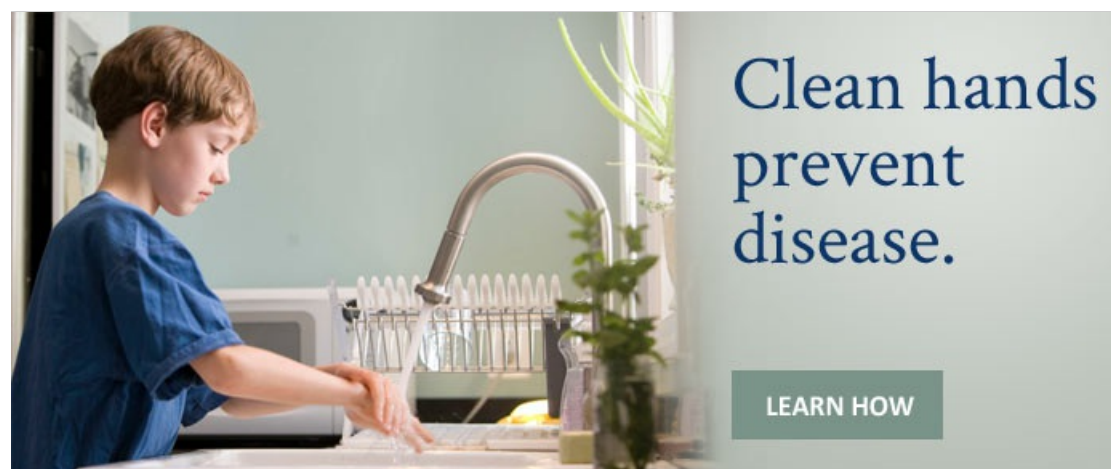
