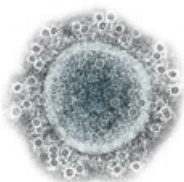


Coronavirus Disease 2019 (COVID-19)

Updated June 21, 2020



The national Centers for Disease Control and Prevention (CDC) and the Mississippi State Department of Health continue to closely monitor the outbreak of respiratory illnesses caused by the novel (new) coronavirus COVID-19, and are working to limit the spread of cases nationally and in Mississippi. MSDH is actively working with doctors and hospitals to quickly identify cases and respond effectively to limit this outbreak.



If you are waiting for test results, it is essential to remain at home if you have symptoms of COVID-19.

Do not go to work or leave home. Stay in a specific room at home and avoid contact with other family members as much as possible.

If you are awaiting results from a **routine screening** test, but have no symptoms, you may return to work under the guidance of your employer (unless otherwise directed by the Mississippi State Department of Health).

Long-Term Care Facility Cases and Outbreaks

Long-term care (LTC) facilities like nursing homes are considered high risk locations because their residents are older or in poor health. Even one case of COVID-19 in these facilities among residents or employees is considered an outbreak. We investigate residents, staff and close contacts of infected individuals for possible exposure. Residential care facilities also represent group living facilities where COVID-19 can be easily spread.

Long-term care facilities include nursing homes, personal care homes, assisted living homes, and intermediate care facilities for individuals with intellectual disability (ICF-IID)

Residential care facilities include psychiatric or chemical dependency residential treatment centers and long-term acute care facilities.

Active Outbreaks

The table of active outbreaks lists all facilities that have reported a current COVID-19 outbreak. Resident and employee totals

are for those cases associated with the current outbreak **only**. The reported deaths are those which have occurred only among the cases in the current outbreak.

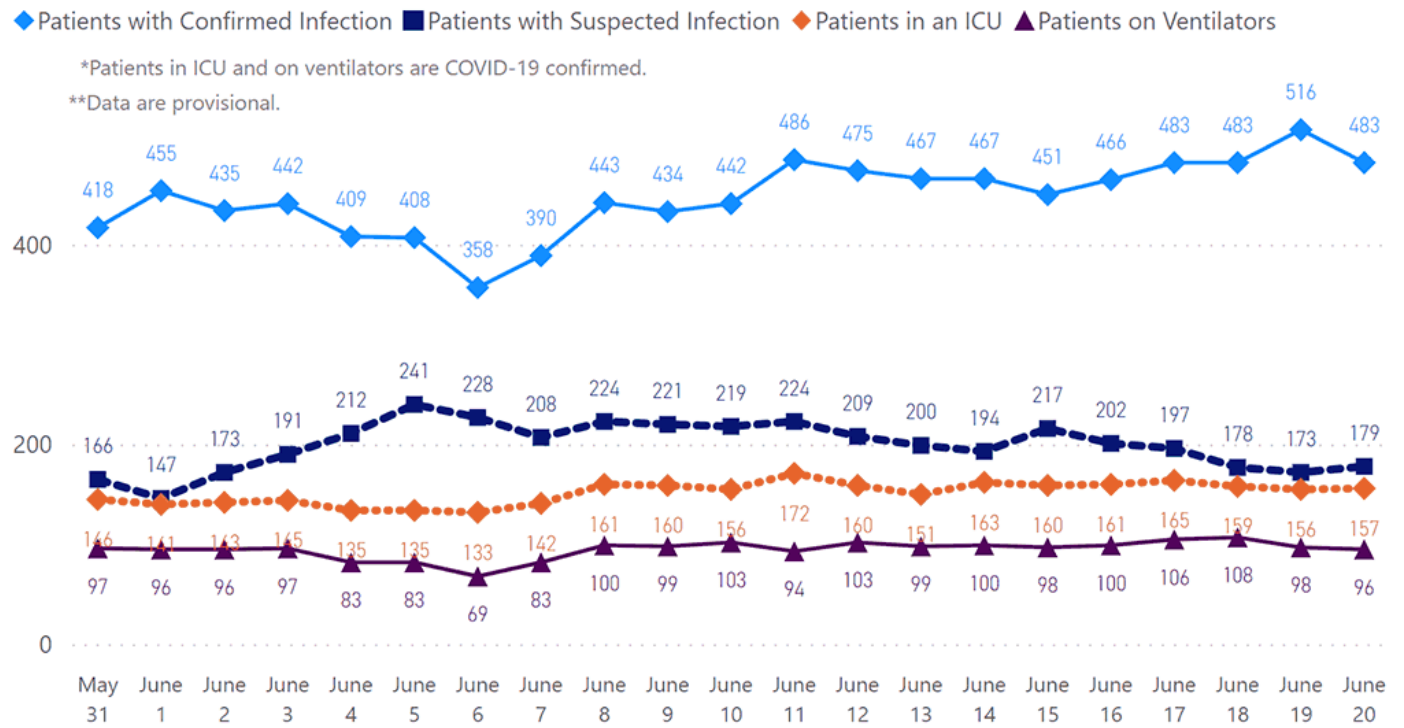
Mississippi COVID-19 Map and Charts

The Mississippi State Department of Health apologizes for the interruption of COVID-19 case data. The agency is working to address legacy software issues impacting its ability to create detailed reports.

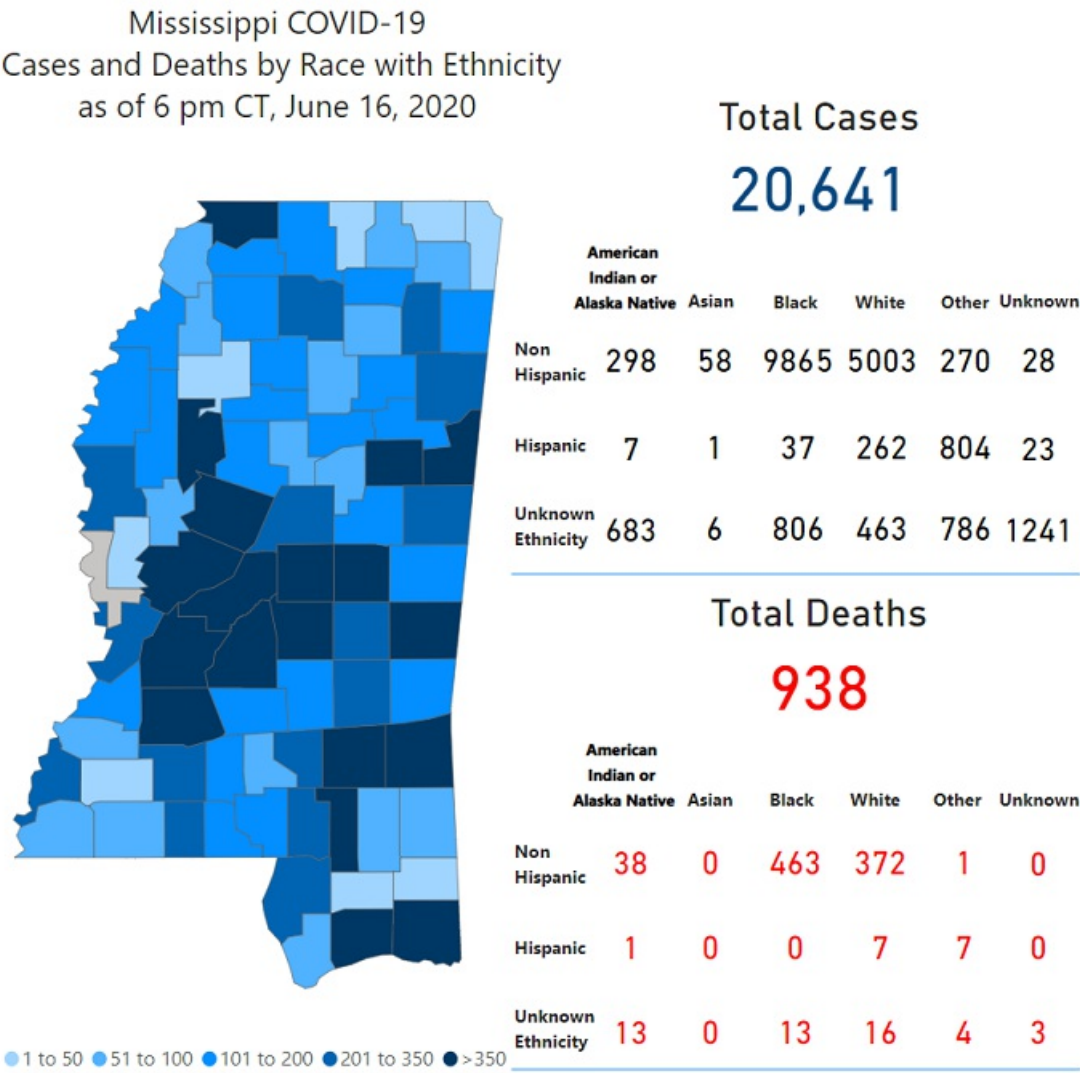
Further detailed data reports and most charts will not be available until the agency resolves these software issues. In the meantime, we will continue to provide daily case counts and deaths on our website and social media.

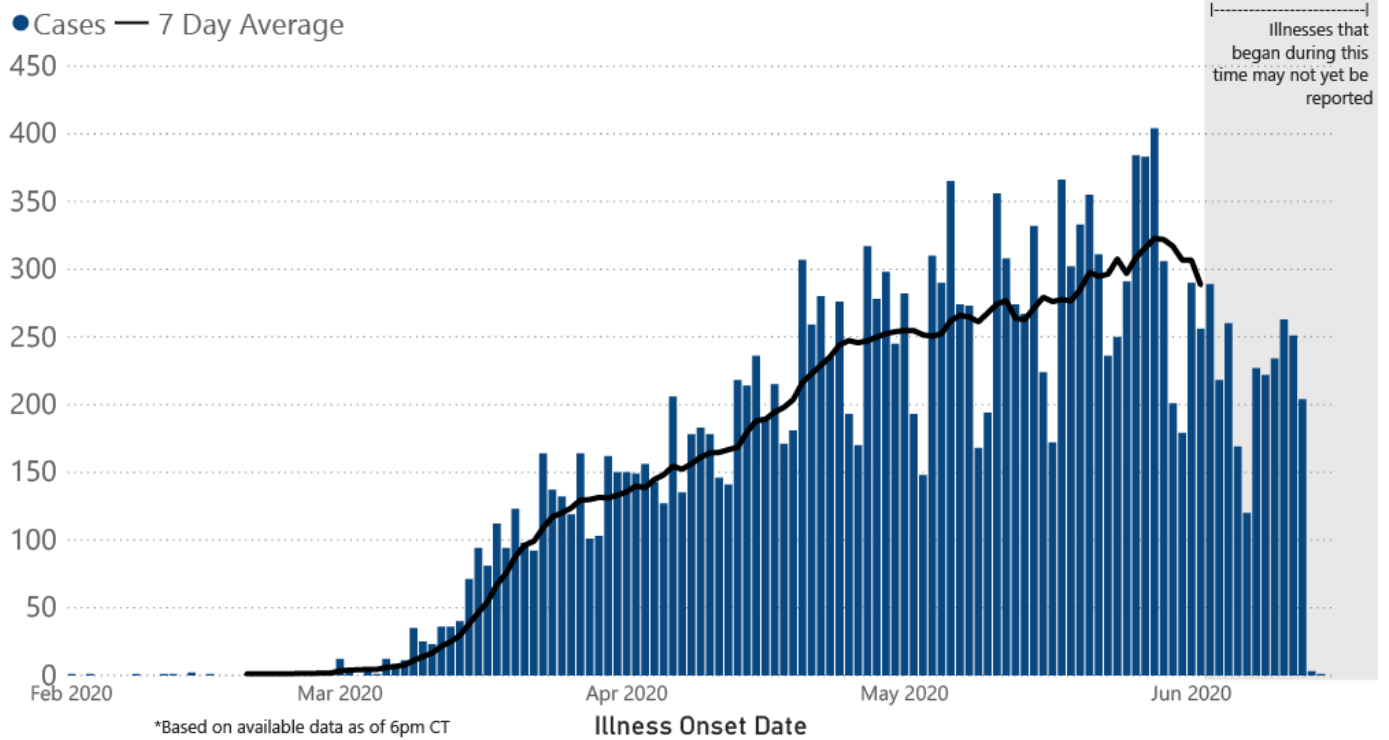

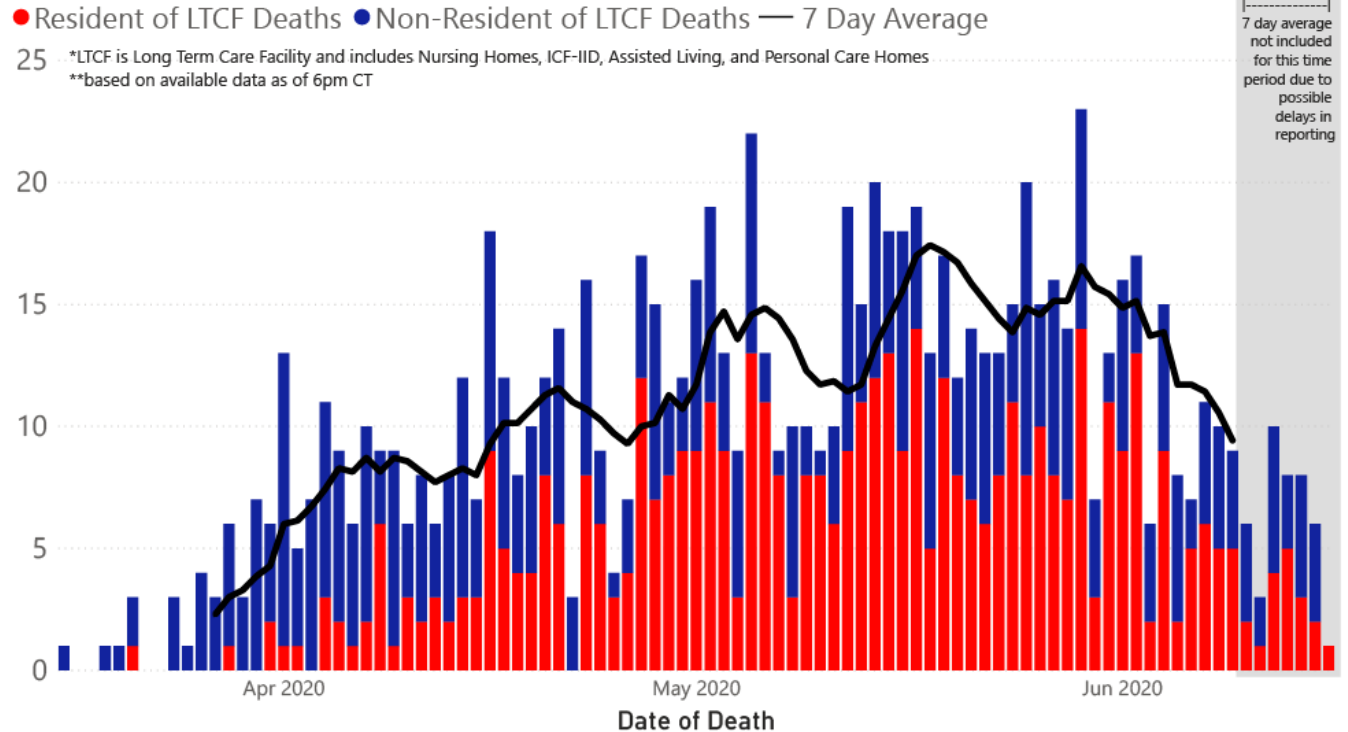


COVID-19 Cases by Date of Illness Onset through June 16, 2020*, Mississippi



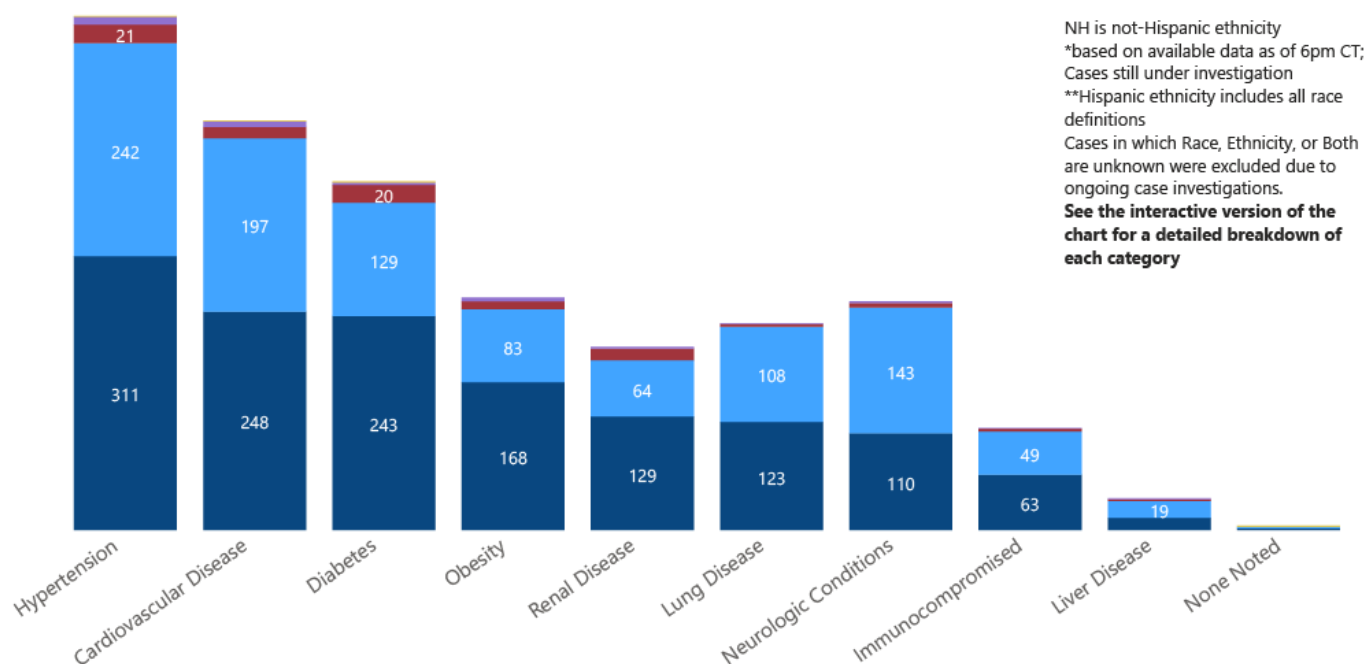
Note: Values up to two weeks in the past on the Date of Illness Onset chart above can change as we update it with new information from disease investigation.

COVID-19 LTCF* and Non-LTCF Deaths by Date of Death through June 16, 2020**, Mississippi

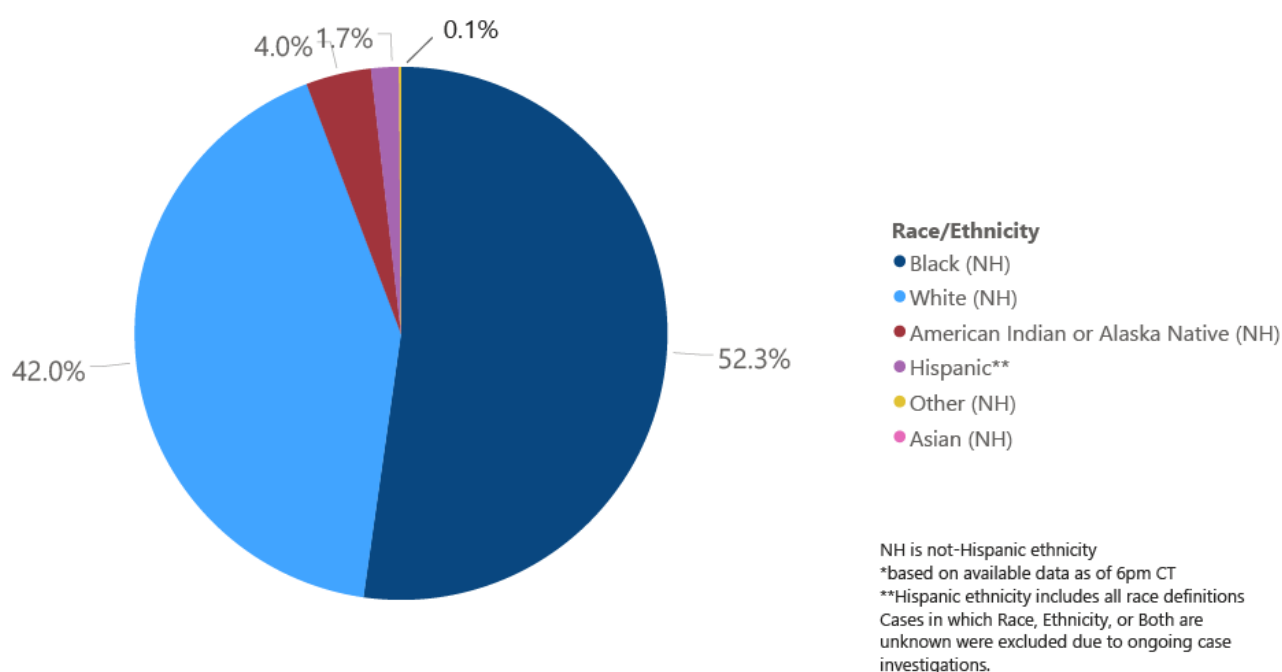


COVID-19 Underlying Conditions in Deaths by Race/Ethnicity through June 16, 2020*, Mississippi

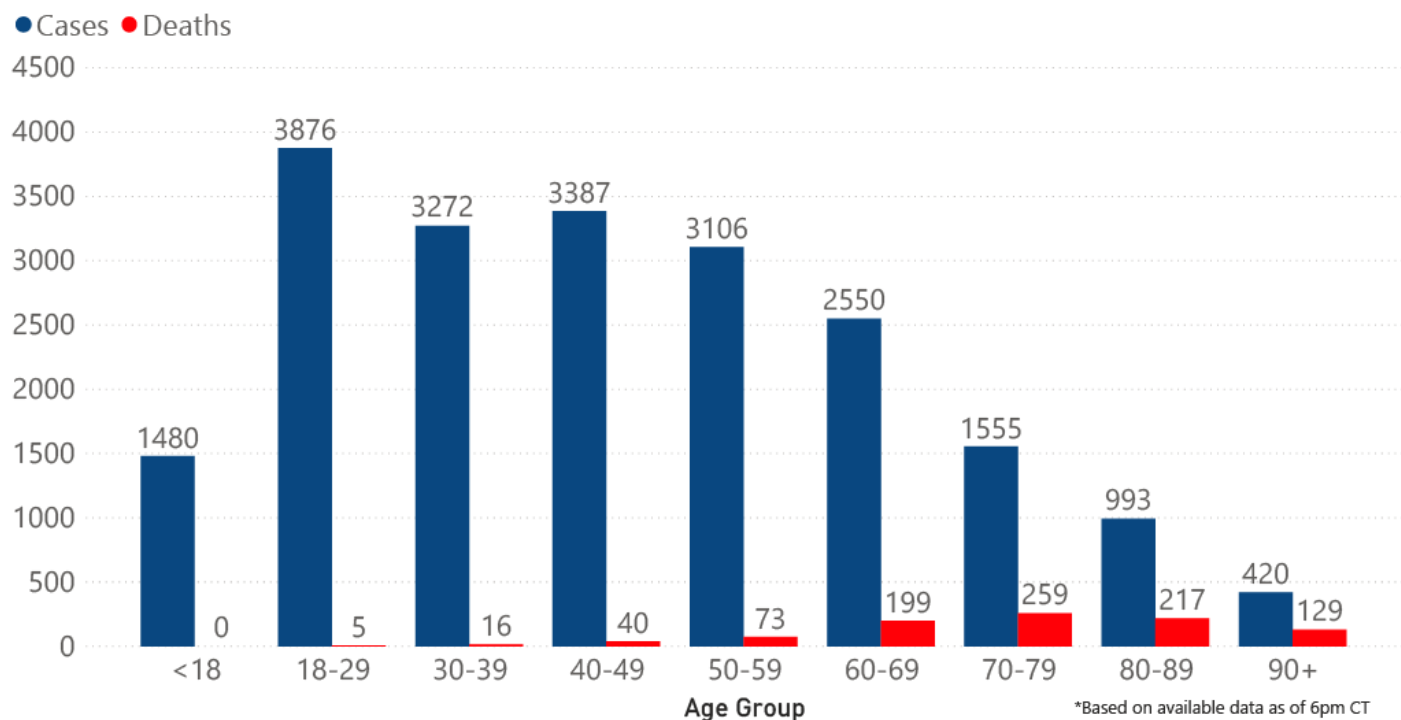

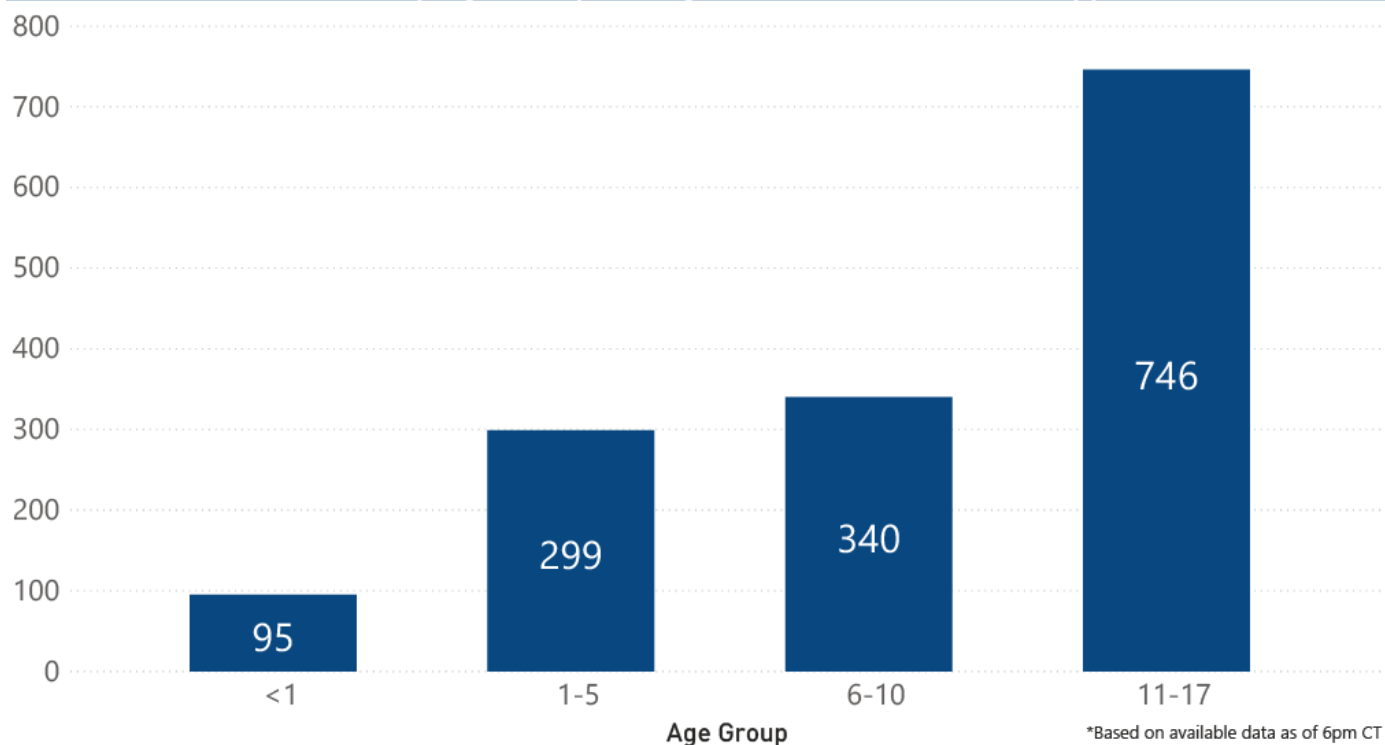
COVID-19 Deaths by Race/Ethnicity through June 16, 2020*, Mississippi



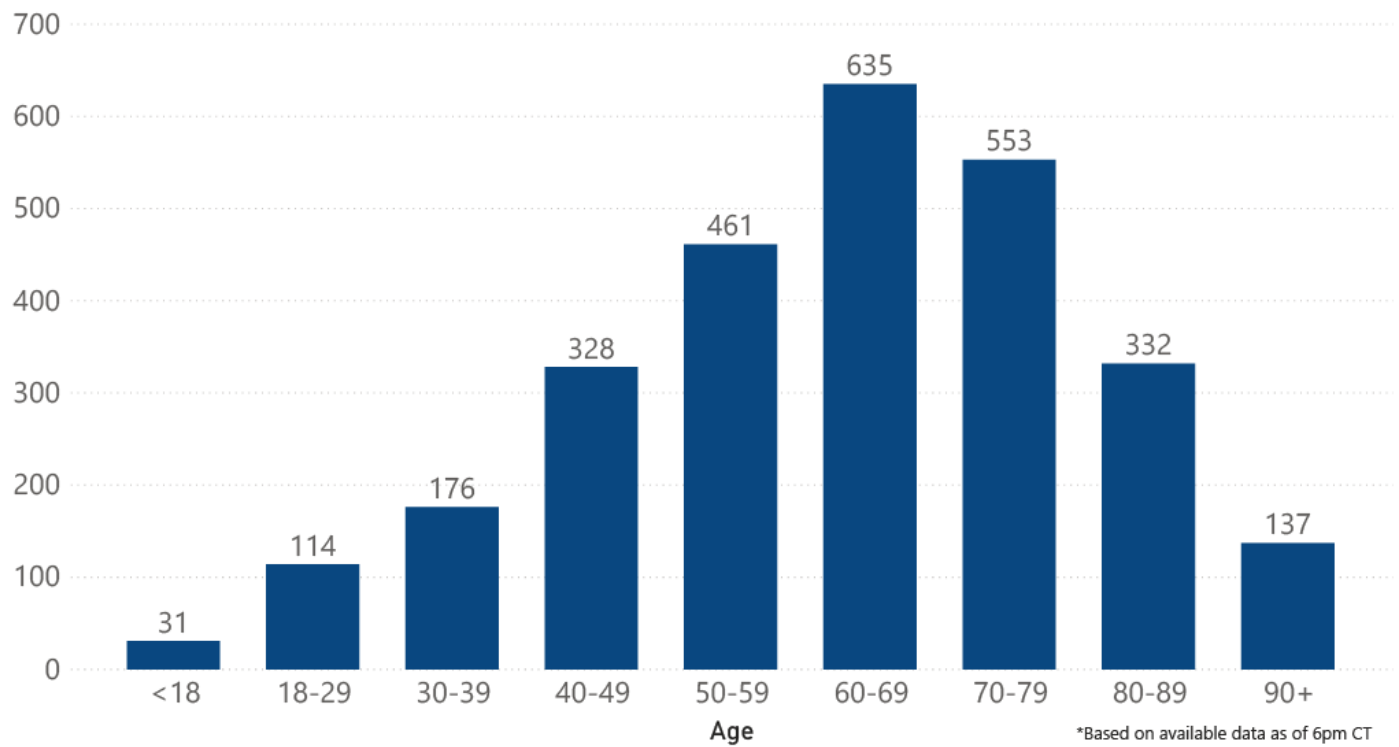
COVID-19 Cases and Deaths by Age Group through June 16, 2020*, Mississippi



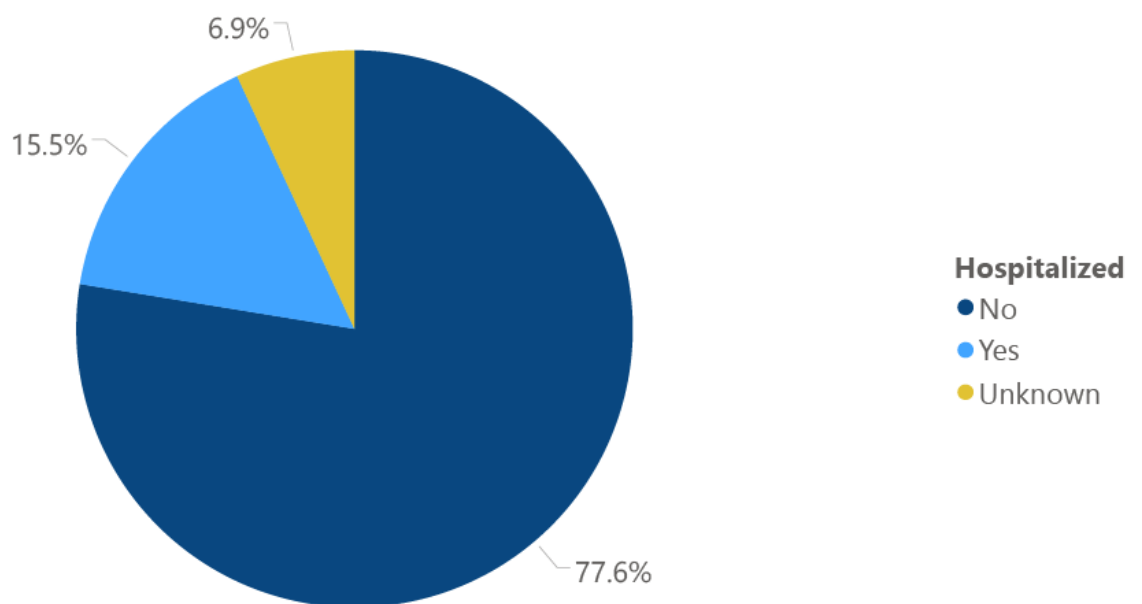
COVID-19 Pediatric Cases by Age Group through June 16, 2020*, Mississippi



COVID-19 Hospitalized Cases by Age through June 16, 2020*, Mississippi



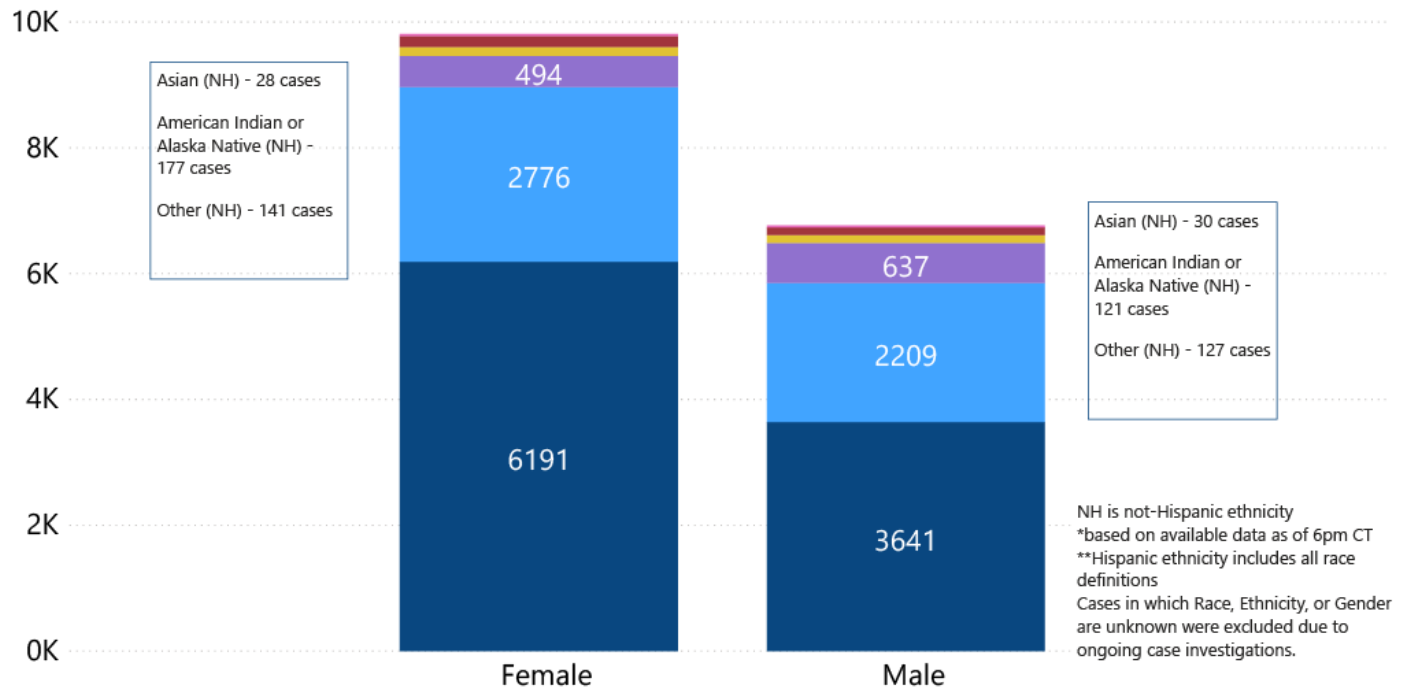
COVID-19 Cumulative Hospitalizations-Investigated Cases June 16, 2020 *

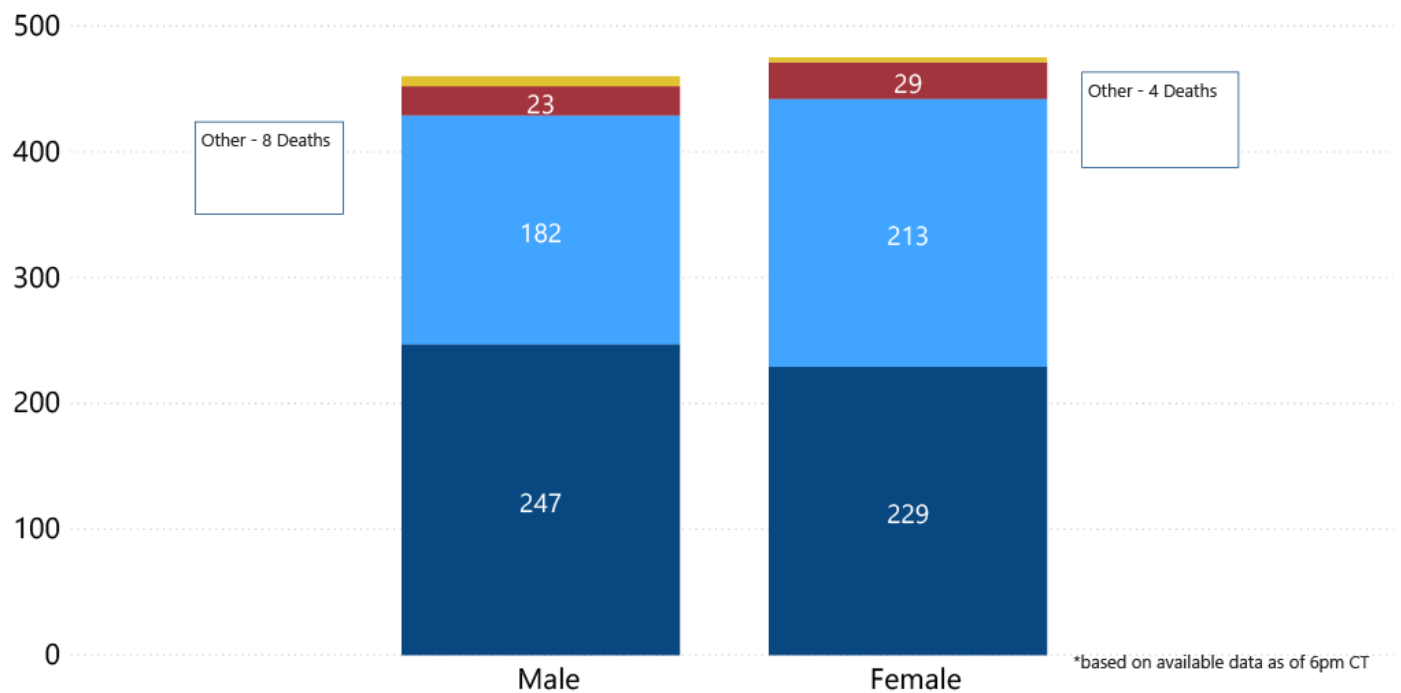
COVID-19 Cases by Race/Ethnicity and Gender through June 16, 2020*, Mississippi

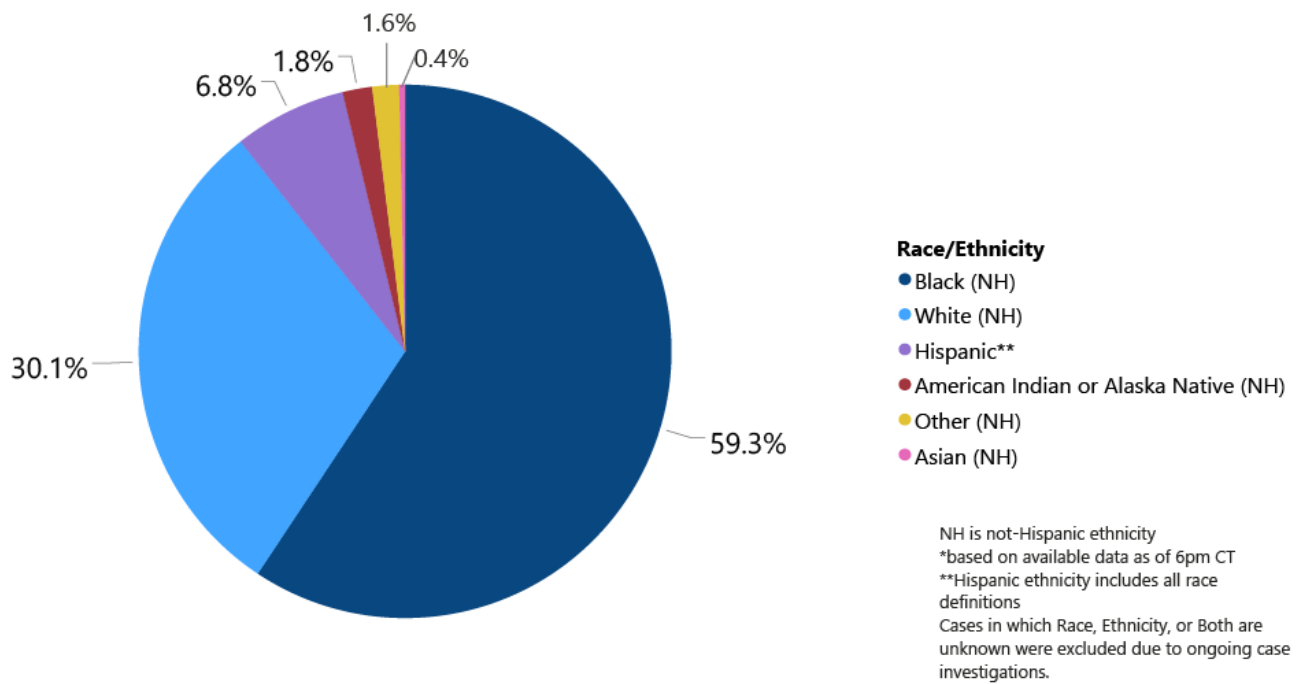


COVID-19 Deaths by Race and Gender through June 16, 2020*, Mississippi

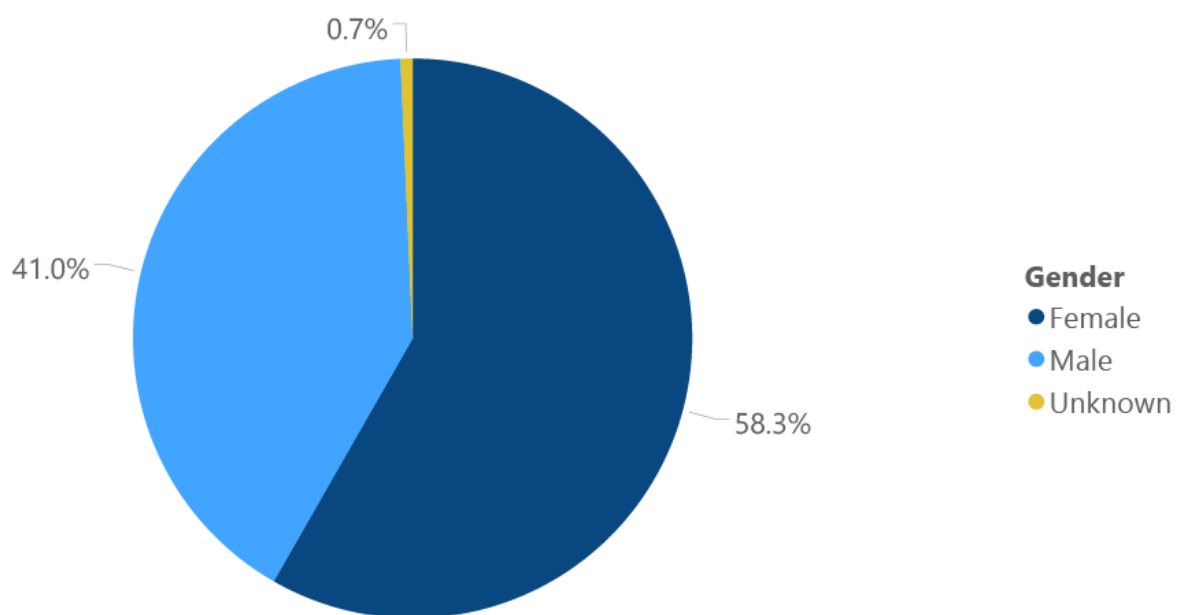

Weekly High Case and High Incidence Counties

These weekly tables count cases based on the date of testing, not the date the test result was reported, and count only those cases where the date of testing is known.

They rank counties by weekly cases, and by incidence (cases proportional to population). A separate table ranking all counties is also available. **All tables updated weekly.**

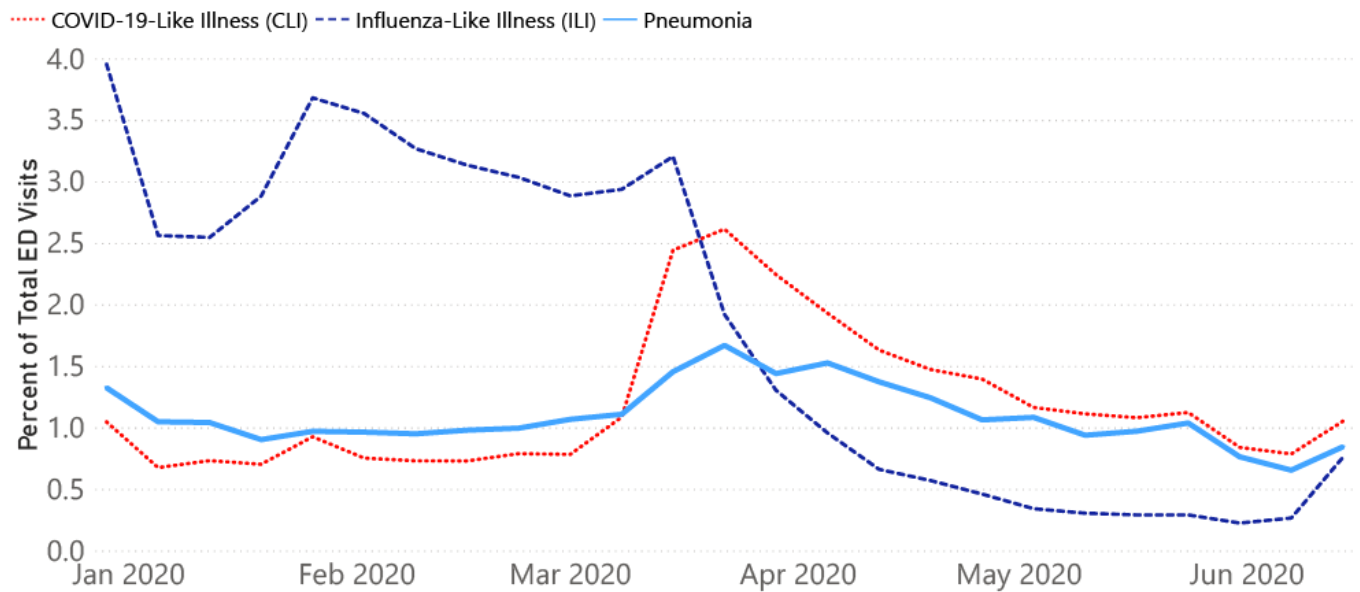

*The graph represents syndromic surveillance data from emergency department visits, reported electronically by hospitals throughout the state, that are consistent with COVID-19-Like Illness (CLI), Influenza-Like Illness (ILI), and Pneumonia. Based on available data as of 6pm CT. Graph will be updated weekly.

Presumed COVID-19 cases recovered, estimated weekly (does not include cases still under investigation).

COVID-19 Testing

Statewide Combined Testing as of June 16

COVID-19 testing providers around the state include commercial laboratories as well as hospital labs. Combined with testing done by the MSDH Public Health Laboratory, the figures provide a complete picture of all Mississippi testing.

PCR testing detects current, active COVID-19 infection in an individual.

Antibody (serology) testing identifies individuals with past COVID-19 infection based on antibodies they develop one to three weeks after infection.

MSDH Individuals Tested as of June 21

MSDH Public Health Laboratory (MPHL) testing totals as of 3 p.m. These totals are for tests performed at the MPHL only.

- Total individuals tested by the MPHL: **44,729**
- Total positive individuals from MPHL tests: **3,654**

Getting Tested for COVID-19

The MSDH Public Health Laboratory, its partners, and private providers are testing statewide for COVID-19.

Anyone with symptoms of fever, severe cough or severe chest pains – especially those who are older or in poor health – should make arrangements for testing with their doctor or one of the many healthcare providers now performing testing. Healthcare providers can assess your health history and symptoms, and perform testing for COVID-19 as needed. MSDH is also helping conduct free drive-up testing sites in many parts of the state. **Always call ahead to the testing provider for instructions on safely being examined before you visit for your test.**

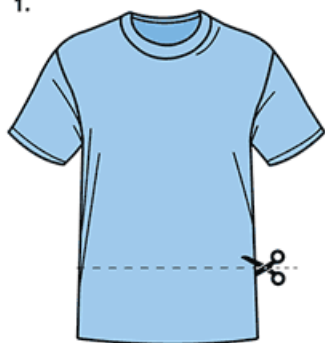

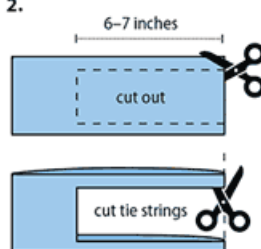
