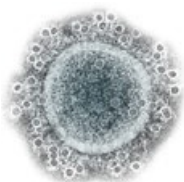


Coronavirus Disease 2019 (COVID-19)

Updated July 15, 2020



The national Centers for Disease Control and Prevention (CDC) and the Mississippi State Department of Health continue to closely monitor the outbreak of respiratory illnesses caused by the novel (new) coronavirus COVID-19, and are working to limit the spread of cases nationally and in Mississippi. MSDH is actively working with doctors and hospitals to quickly identify cases and respond effectively to limit this outbreak.

New mask and social distancing requirements for selected counties

Based on the Governor's [executive order 1507](#), the following counties must practice enhanced safety protocols, including the use of a mask or face covering in public and additional limits on social gathering sizes, beginning July 13, 2020.

- Claiborne, De Soto, Grenada , Harrison, Hinds, Jackson, Jefferson, Madison, Quitman, Rankin, Sunflower, Washington, Wayne

In all businesses:

- All employees are required to keep at least 6 feet from other employees, or wear a face mask.
- All employees must be screened at the beginning of their shift.

In retail businesses:

- Employees in contact with the public must wear a face covering.
- Members of the public must wear a face covering at all times in a retail business.

Gatherings and events:

- Social gatherings are limited to 10 individuals indoors and 20 outdoors, and a distance of at least six feet between individuals must be maintained.
- A distance of six feet or more must be maintained between others at all public events, indoors and out, or else face coverings must be worn.

About our case counts: We currently update our case totals each day based on test results from the previous day. Outside laboratories also report positive test results to us, which are included in our totals. Repeated tests for the same individual are counted only once. County case numbers and deaths may change as investigation finds new or additional information.

Case Classifications

Mississippi investigates and reports both probable and confirmed cases and deaths according to the [CSTE case definition](#).

Confirmed cases and deaths are generally determined by positive PCR tests, which detect the presence of ongoing coronavirus infection.

Probable cases are those who test positive by other testing methods such as antibody or antigen, and have recent symptoms consistent with COVID-19, indicating a recent infection.

Probable deaths are those individuals with a designation of COVID-19 as a cause of death on the death certificate, but where no confirmatory testing was performed.

Long-Term Care Facility Cases and Outbreaks

Long-term care (LTC) facilities like nursing homes are considered high risk locations because their residents are older or in poor health. Even one case of COVID-19 in these facilities among residents or employees is considered an outbreak. We investigate residents, staff and close contacts of infected individuals for possible exposure. Residential care facilities also represent group living facilities where COVID-19 can be easily spread.

Long-term care facilities include nursing homes, personal care homes, assisted living homes, and intermediate care facilities for individuals with intellectual disability (ICF-IID)

Active Outbreaks

The table of active outbreaks lists all facilities that have reported a current COVID-19 outbreak. Resident and employee totals are for those cases associated with the current outbreak **only**. The reported deaths are those which have occurred only among the cases in the current outbreak.

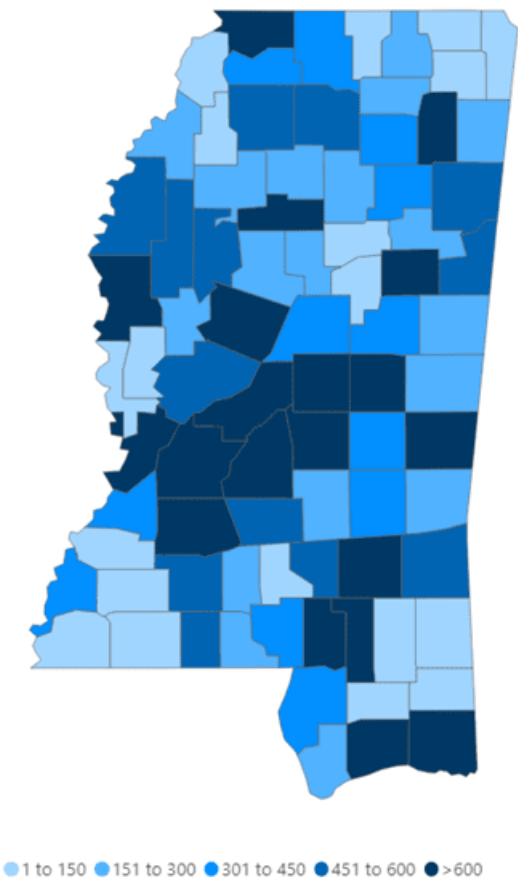

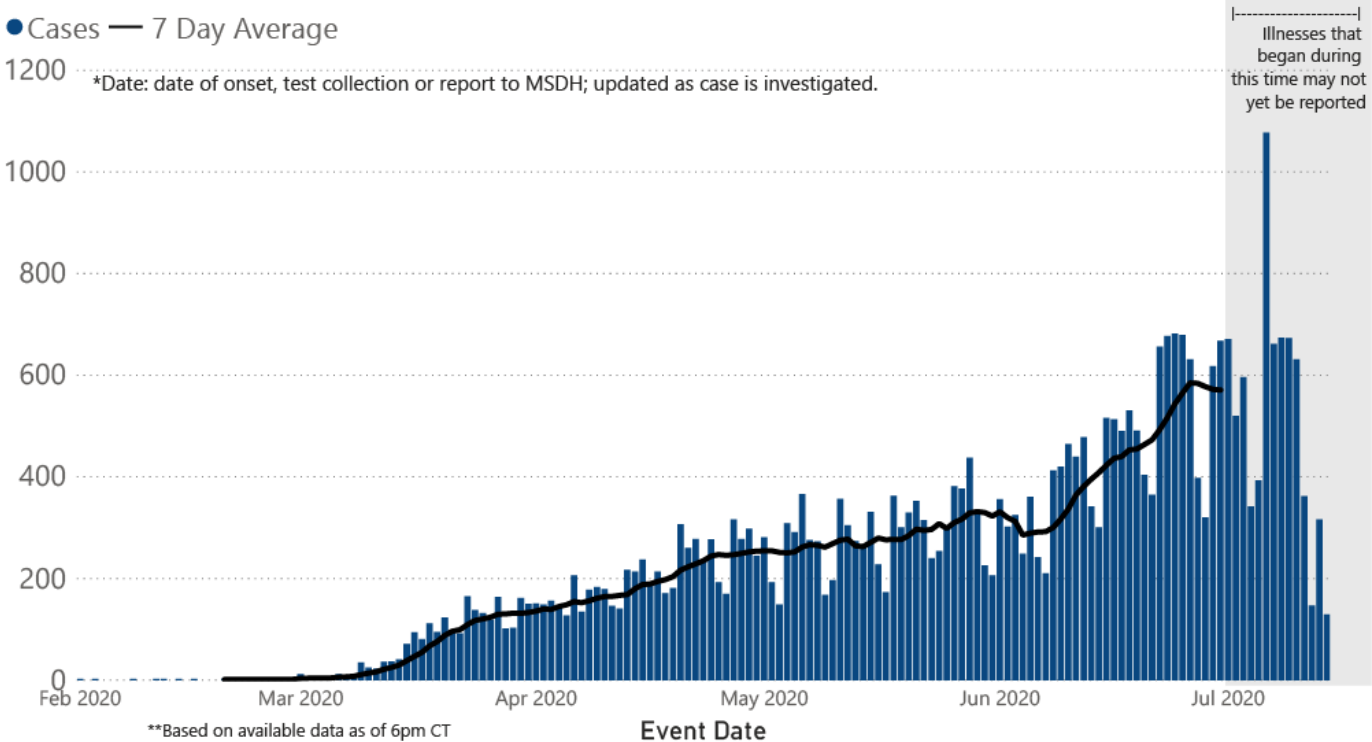

● Cases — 7 Day Average

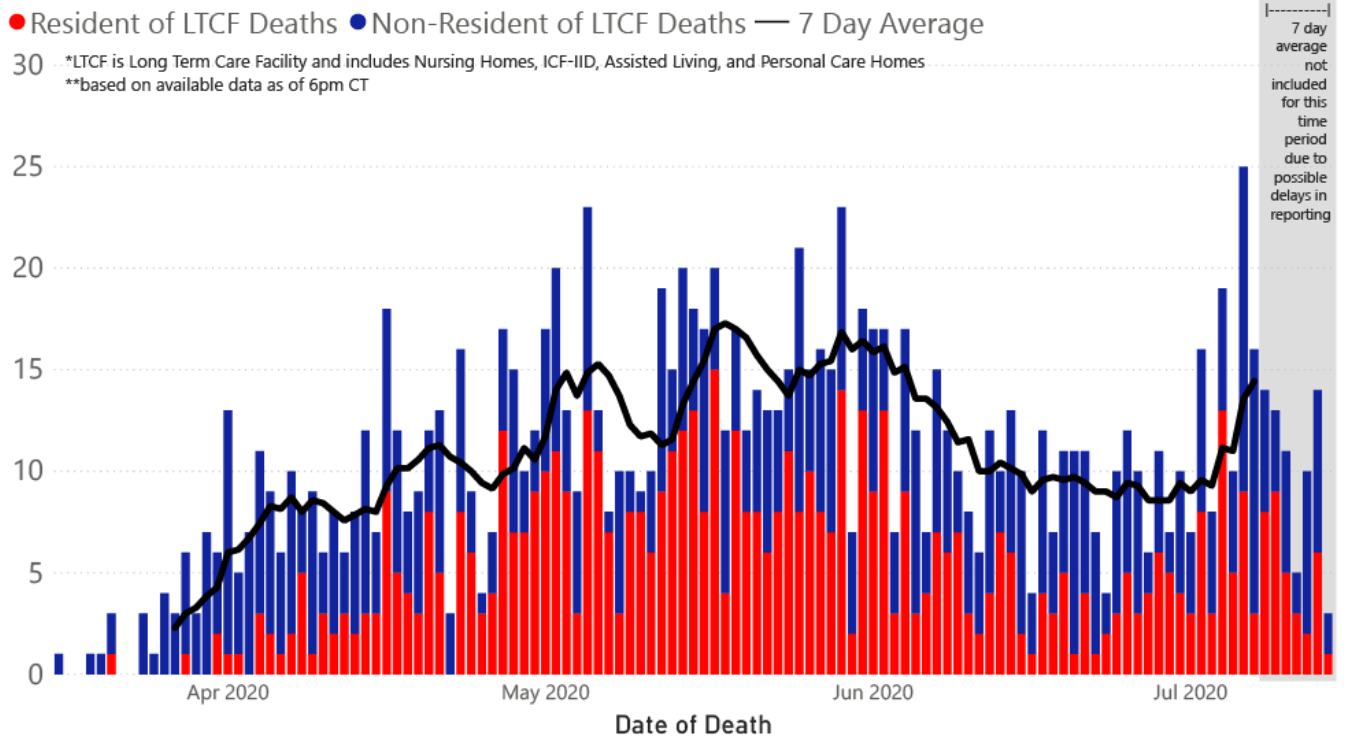

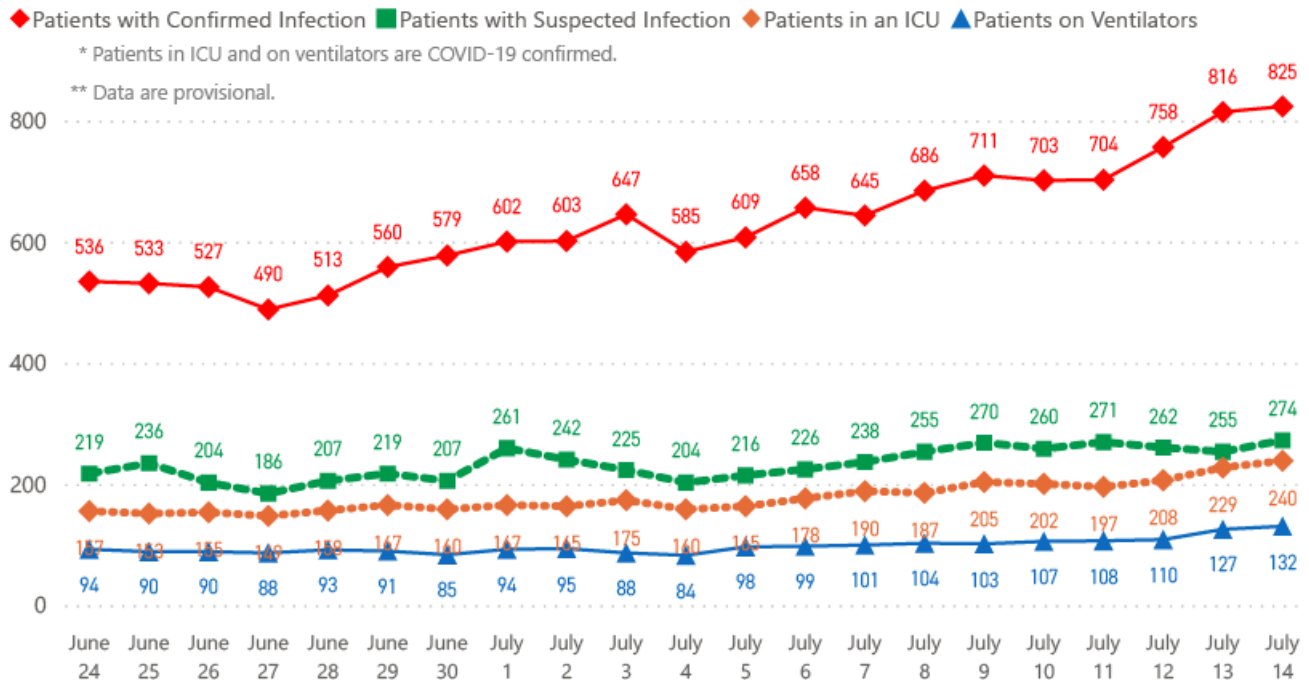

COVID-19 LTCF* and Non-LTCF Deaths by Date of Death through July 14, 2020**, Mississippi

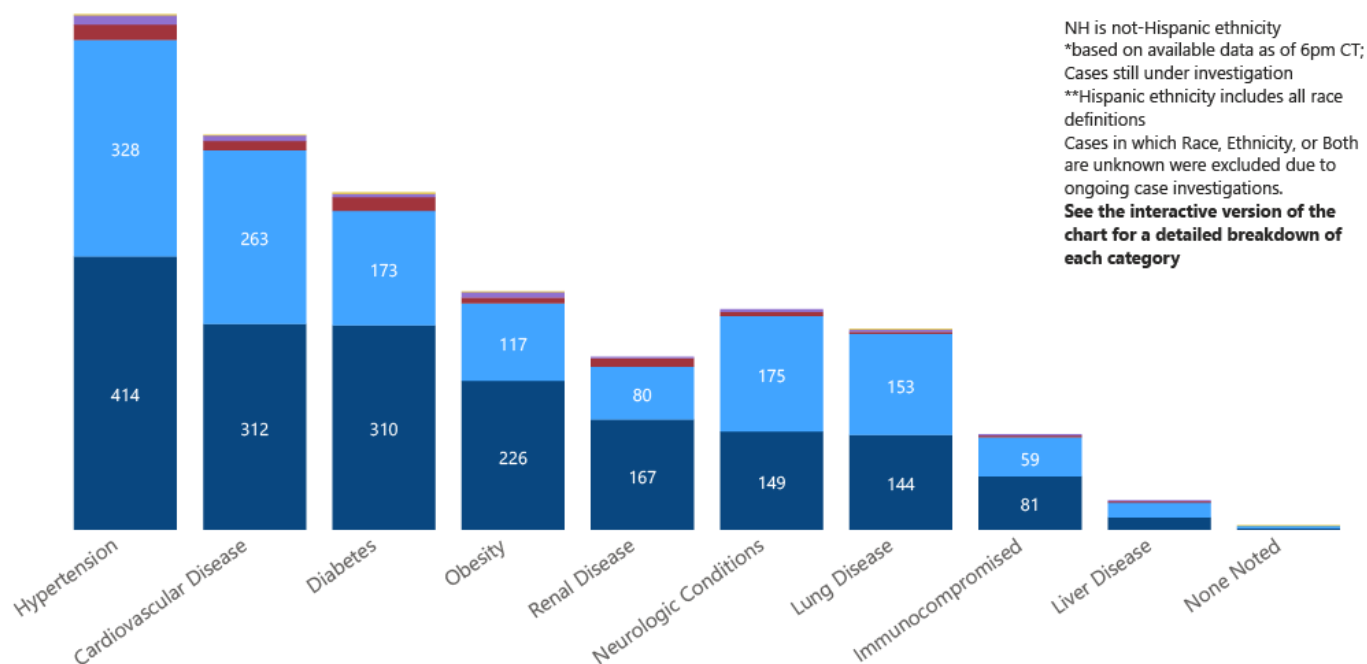


COVID-19 Hospitalizations Reported by MS Hospitals, 6/24/20-7/14/20 **, **

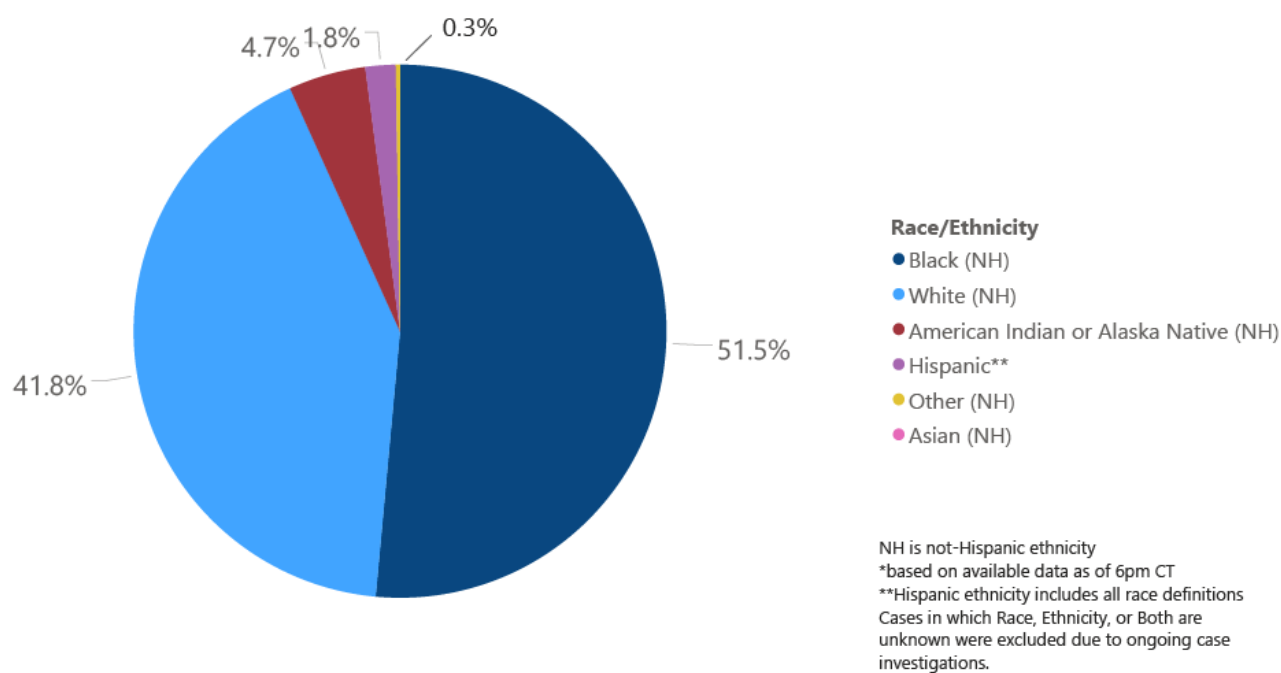


COVID-19 Underlying Conditions in Deaths by Race/Ethnicity through July 14, 2020*, Mississippi

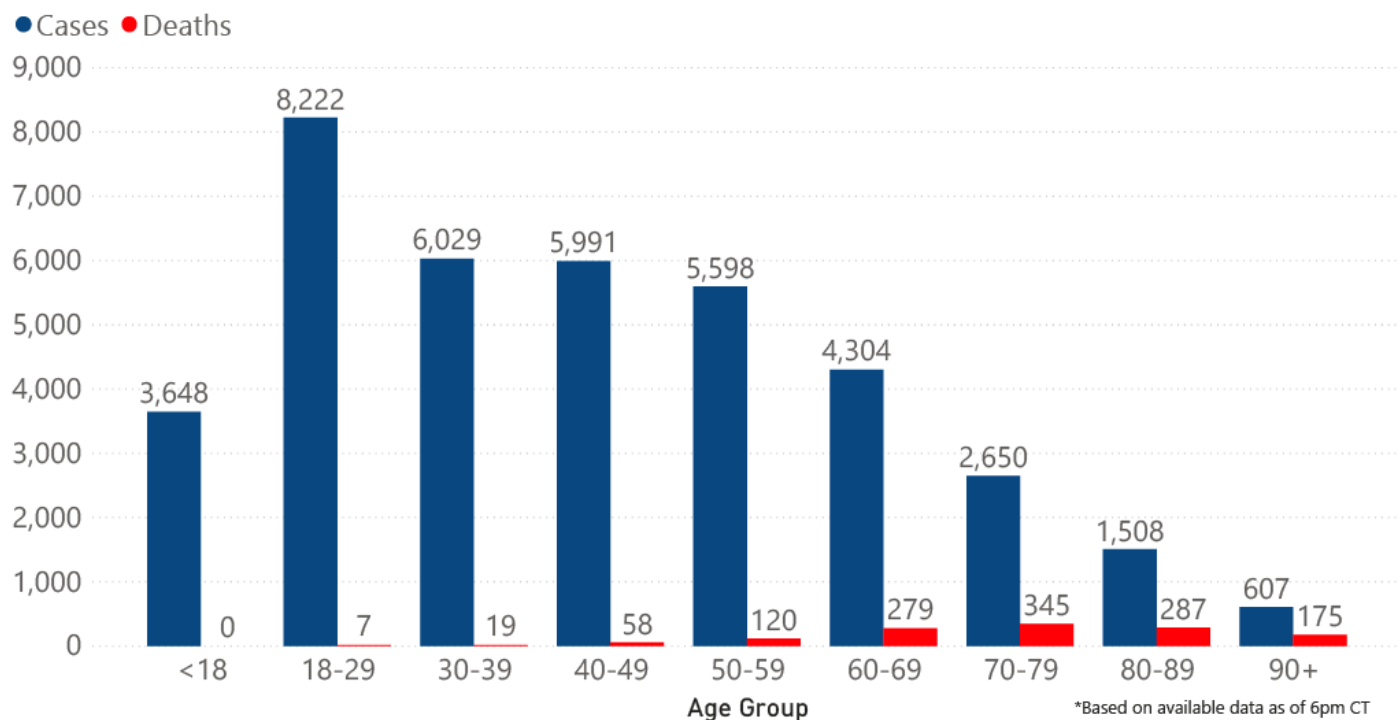

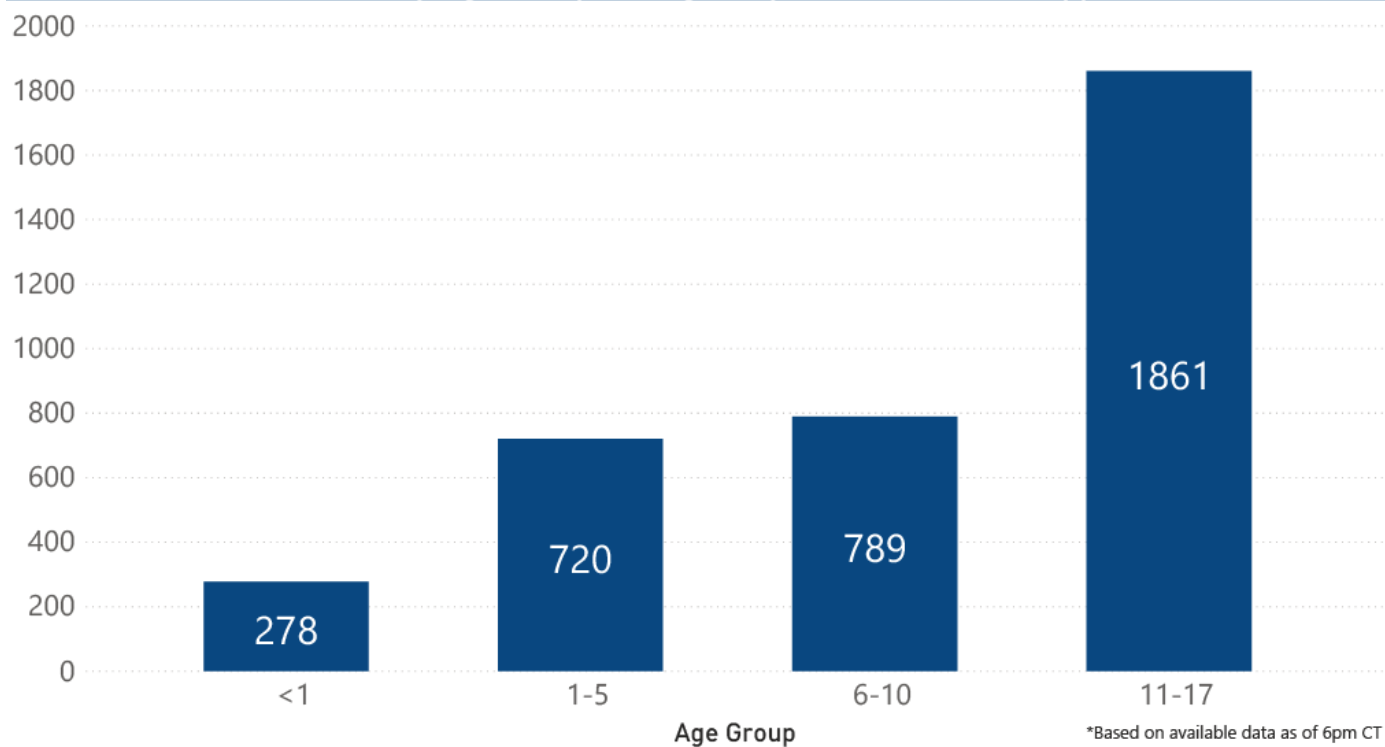
COVID-19 Deaths by Race/Ethnicity through July 14, 2020*, Mississippi



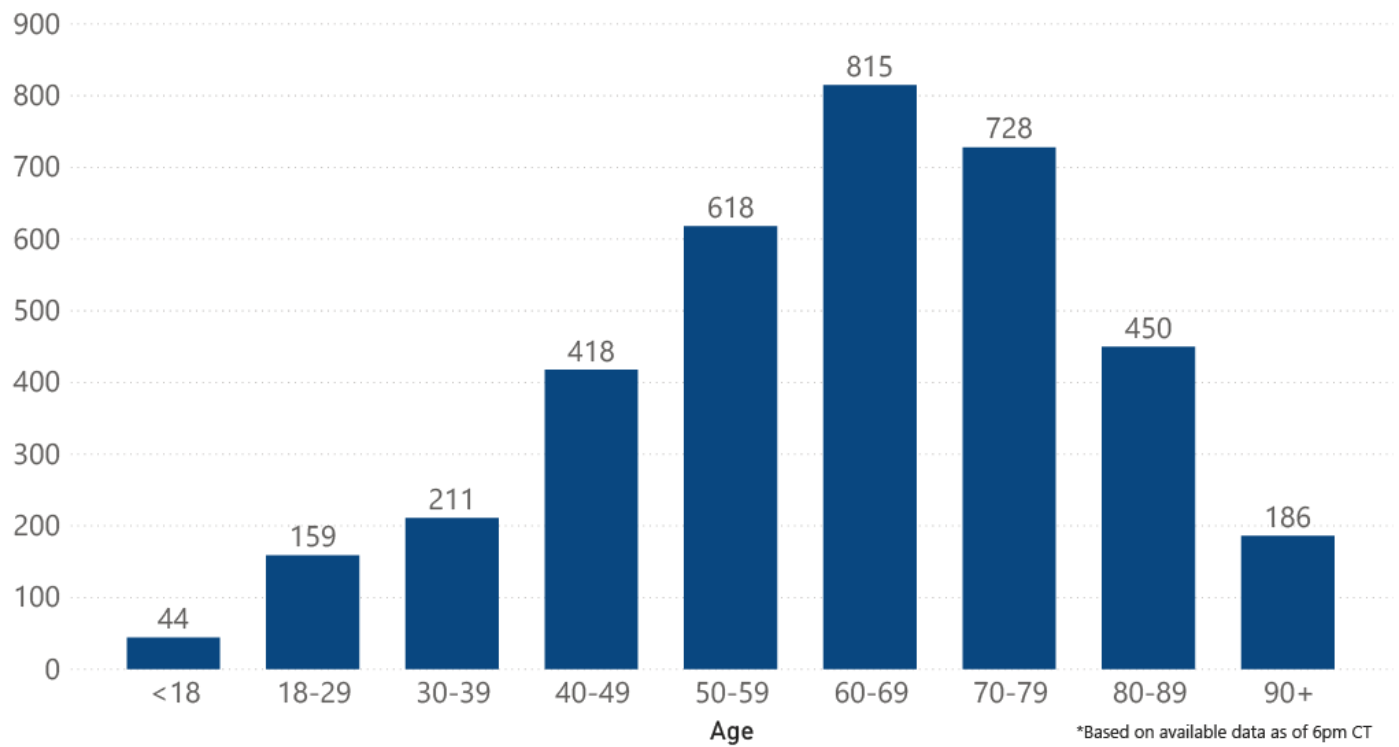
COVID-19 Cases and Deaths by Age Group through July 14, 2020*, Mississippi



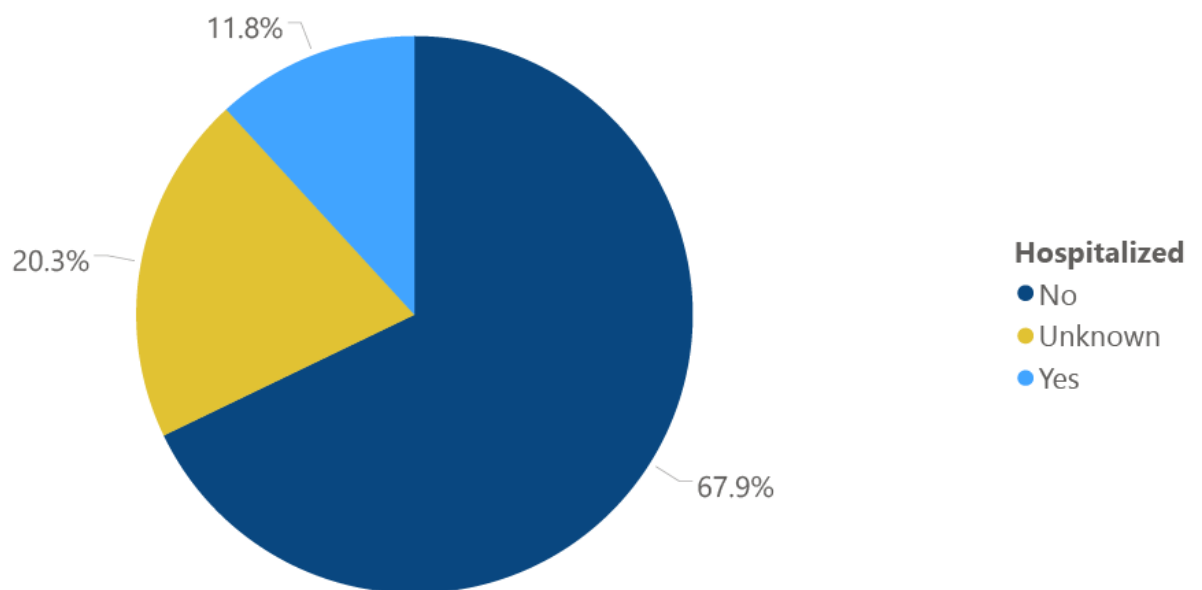
COVID-19 Pediatric Cases by Age Group through July 14, 2020*, Mississippi



COVID-19 Hospitalized Cases by Age through July 14, 2020*, Mississippi



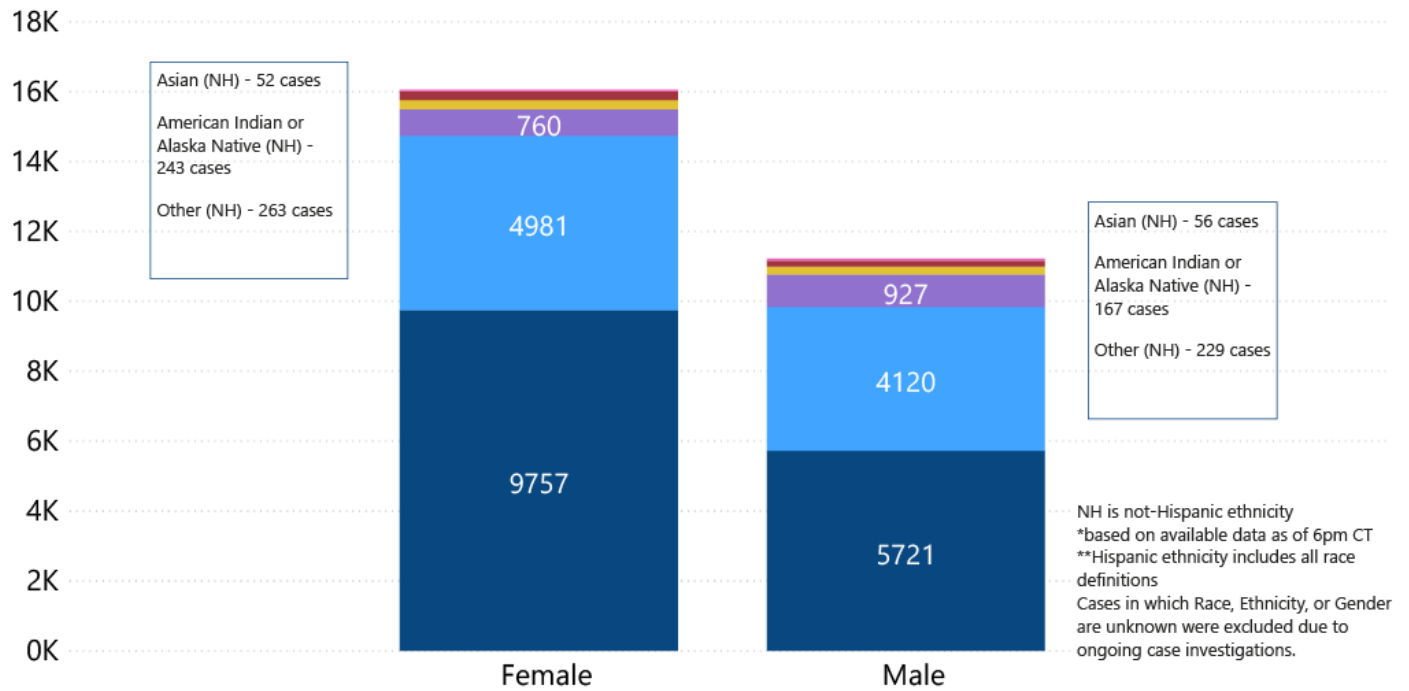
COVID-19 Cumulative Hospitalizations-Investigated Cases July 14, 2020 *

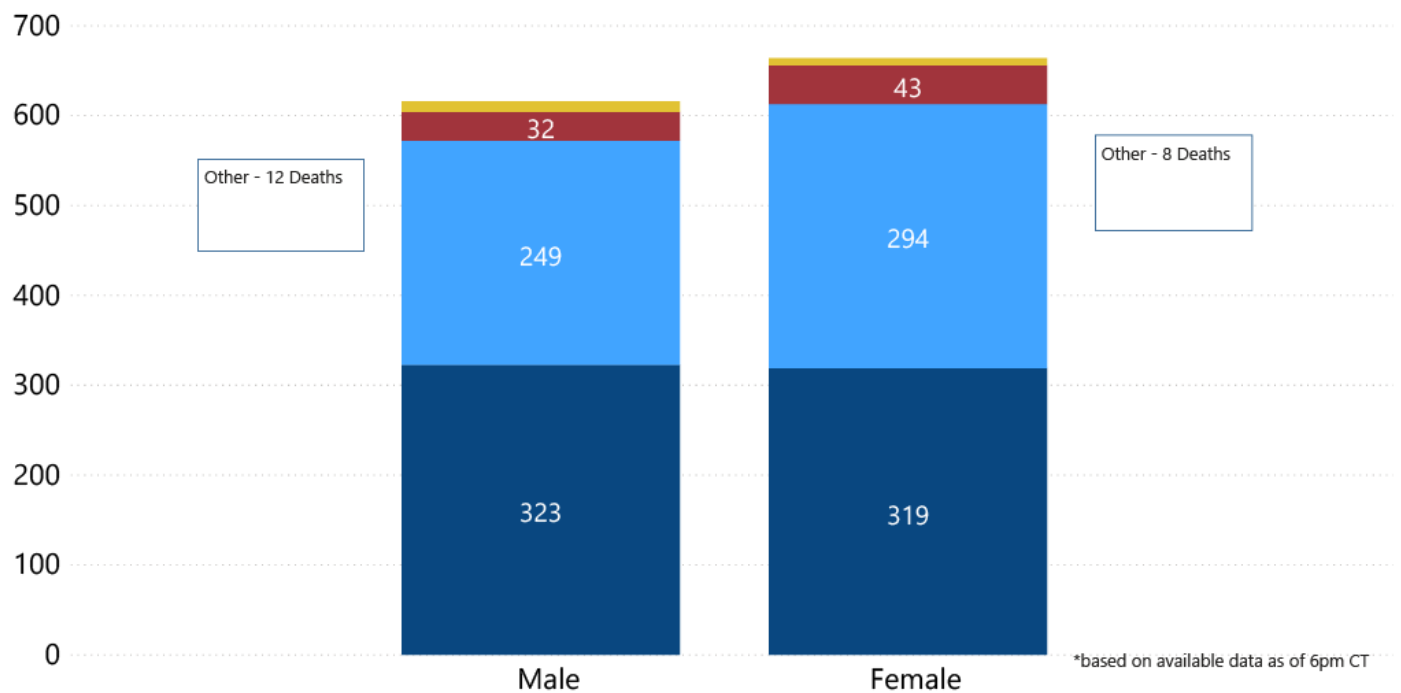
COVID-19 Cases by Race/Ethnicity and Gender through July 14, 2020*, Mississippi

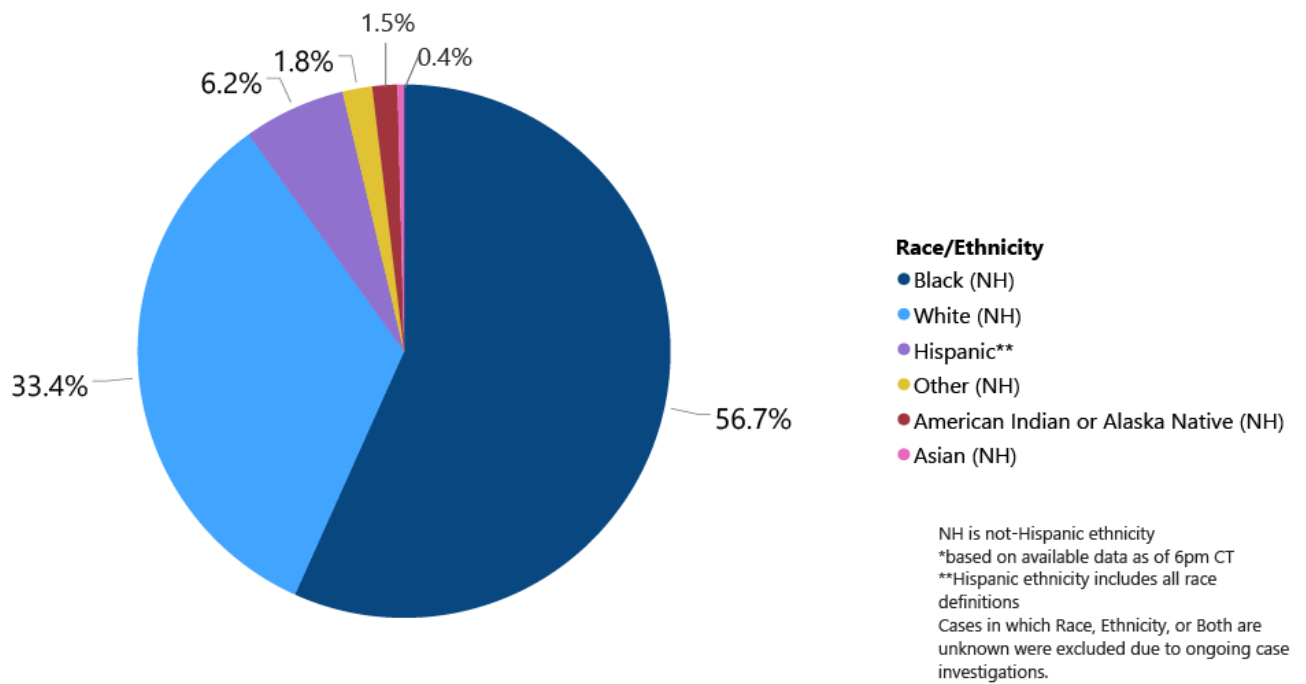


COVID-19 Deaths by Race and Gender through July 14, 2020*, Mississippi

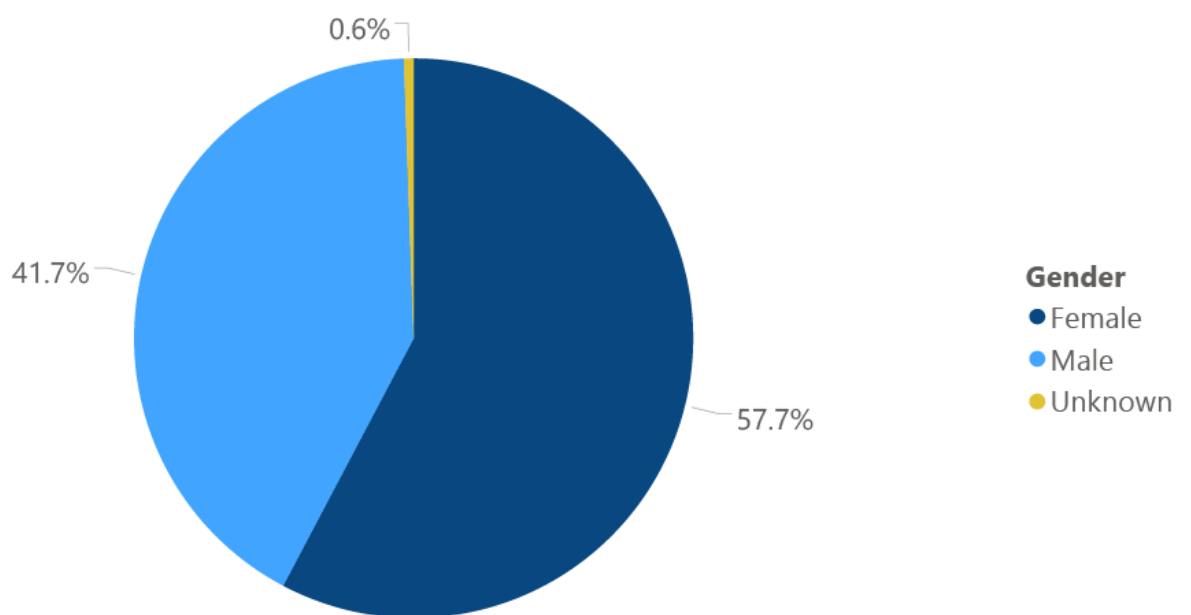

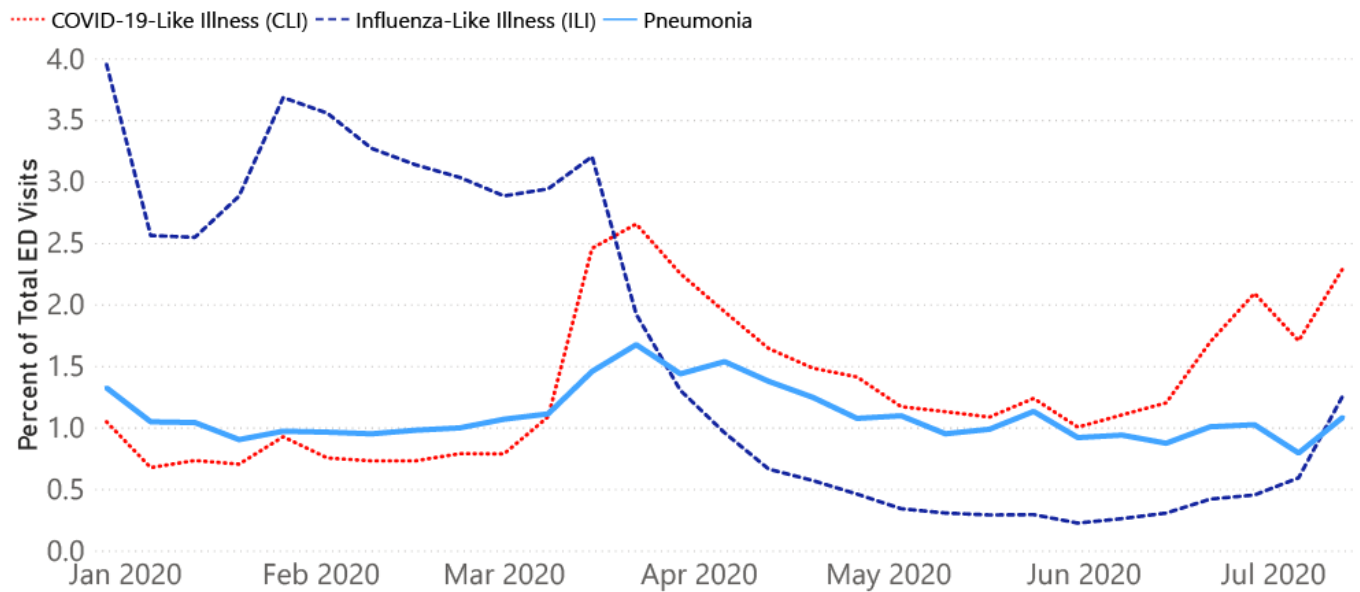

COVID-19 Testing

Statewide Combined Testing as of July 14

COVID-19 testing providers around the state include commercial laboratories as well as hospital labs. Combined with testing done by the MSDH Public Health Laboratory, the figures provide a complete picture of all Mississippi testing.

PCR testing detects current, active COVID-19 infection in an individual.

Antibody (serology) testing identifies individuals with past COVID-19 infection based on antibodies they develop one to three weeks after infection.

Getting Tested for COVID-19

The MSDH Public Health Laboratory, its partners, and private providers are testing statewide for COVID-19.

Anyone with symptoms of fever, severe cough or severe chest pains – especially those who are older or in poor health – should make arrangements for testing with their doctor or one of the many healthcare providers now performing testing. Healthcare providers can assess your health history and symptoms, and perform testing for COVID-19 as needed. MSDH is also helping conduct free drive-up testing sites in many parts of the state. **Always call ahead to the testing provider for instructions on safely being examined before you visit for your test.**
