As commercial testing capacities increase, the coordination of patient and associated contact investigations is paramount to preventing and mitigating the spread of the virus. While performing public health priority activities, including notifying the patient, raising awareness among our communities is valuable. We will provide data as it is available, verified and pertinent.

\* Prior to the MSPHL's approval to test for the virus that causes COVID-19 on Feb. 27, the CDC was performing testing for Missourians. The first 9 patients were tested by the CDC.

\*\* Cases by county will be updated as information is verified and patients are notified. The breakdown may not match the total case count above.

\*\*\* COVID-19 is a reportable disease. Regardless of whether the testing is done by the State or commercially, positive results must be reported to state and federal officials. As commercial labs increase their capacities to test for COVID-19, reporting of such cases may be delayed as data is supplied, received and processed. Often, local public health partners may be advised prior to DHSS.

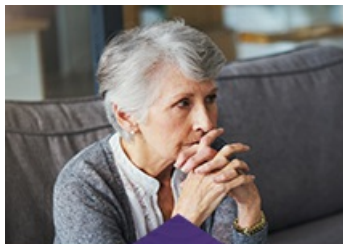

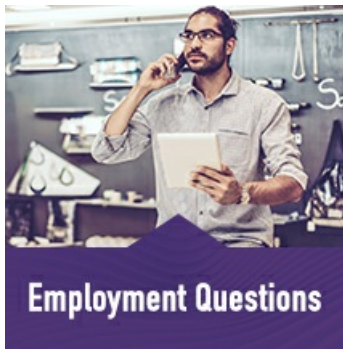
