It is important to note that results received from these labs are from patient samples taken over a period of time due to potential testing backlogs. As commercial labs increase their capacity for testing, we will continue to receive results from them requiring immediate verification of patient data for each result. Prompt efforts to protect the public's health depends on this verification. Patient data from commercial labs is preliminary and subject to change following initial public health involvement.
