As commercial testing capacities increase, the coordination of patient and associated contact investigations is paramount to preventing and mitigating the spread of the virus. While performing public health priority activities, including notifying the patient, raising awareness among our communities is valuable. Labs are required by the Missouri Code of State Regulations to immediately report positive COVID-19 test results. As commercial labs increase their capacity for testing, we will continue to receive results from them requiring immediate verification of patient data for each result. Prompt efforts to protect the public's health depends on this verification. Patient data from commercial labs is preliminary and subject to change following initial public health involvement.
