

## **COVID-19 Testing Information**

Testing is available 7 days a week

Montana state and local public health officials are monitoring the novel coronavirus disease (COVID-19) situation very closely. <u>Governor's Coronovirus Task Force</u>

To help prevent the spread of COVID-19 and other respiratory illnesses, you can take simple steps to protect yourself and your family.

- Stay home if you're sick,
- Avoid contact with sick people when possible,
- Cover your cough and sneezes with the crook of your elbow or a tissue
- Avoid touching your eyes, nose and mouth and wash your hands frequently
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe

Call ahead to a healthcare professional if you develop a fever and symptoms of respiratory illness, such as cough or difficulty breathing, and have been in close contact with a person known to have COVID-19 or if you live in or have recently traveled to an area with ongoing spread. Tell your healthcare professional about your recent travel or contact. Your healthcare professional will work

- are exhibiting symptoms of a compatible illness without other cause after medical examination.

Patients tested may not have been under monitoring at the time of testing.
