- June 17, 2020 – Navajo Department of Health issues new Public Health Order for two 57-hour weekend lockdowns and limits travel outside the Navajo Nation
- June 8, 2020 – Navajo Department of Health issues new Public Health Orders to allow “drive-in” gatherings with safety protocols and extends duration of daily curfew
- May 15, 2020 - Navajo Health Command Operation Center implements Unified Command Group to respond to COVID-19 efforts on the Navajo Nation
- May 8, 2020 - Navajo Nation Health Command Operations Center reports 119 new COVID-19 cases, and eight new deaths
- May 7, 2020 - Navajo Nation Health Command Operations Center reports 103 new COVID-19 cases, and three new deaths
- May 6, 2020 - Navajo Nation Health Command Operations Center reports 95 new COVID-19 cases, and six new deaths
- May 5, 2020 – Navajo Nation Health Command Operations Center reports 85 new COVID-19 cases, and six new deaths
- May 5, 2020 – The Navajo Nation Health Command Operations Center reports 101 new COVID-19 cases, and no new deaths
