- **June 17, 2020** – Navajo Department of Health issues new Public Health Order for two 57-hour weekend lockdowns and limits travel outside the Navajo Nation
- **June 8, 2020** – Navajo Department of Health issues new Public Health Orders to allow “drive-in” gatherings with safety protocols and extends duration of daily curfew
- **May 15, 2020** - Navajo Health Command Operation Center implements Unified Command Group to respond to COVID-19 efforts on the Navajo Nation
- **May 8, 2020** - Navajo Nation Health Command Operations Center reports 119 new COVID-19 cases, and eight new deaths
- **May 7, 2020** - Navajo Nation Health Command Operations Center reports 103 new COVID-19 cases, and three new deaths
