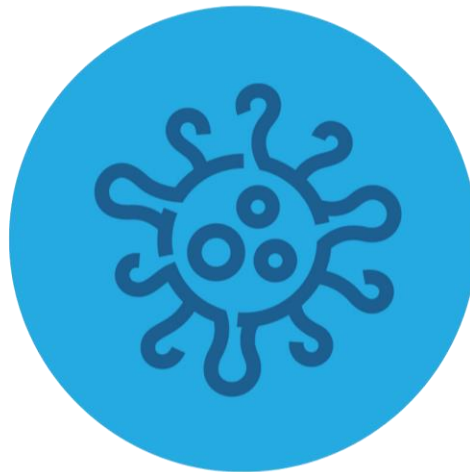

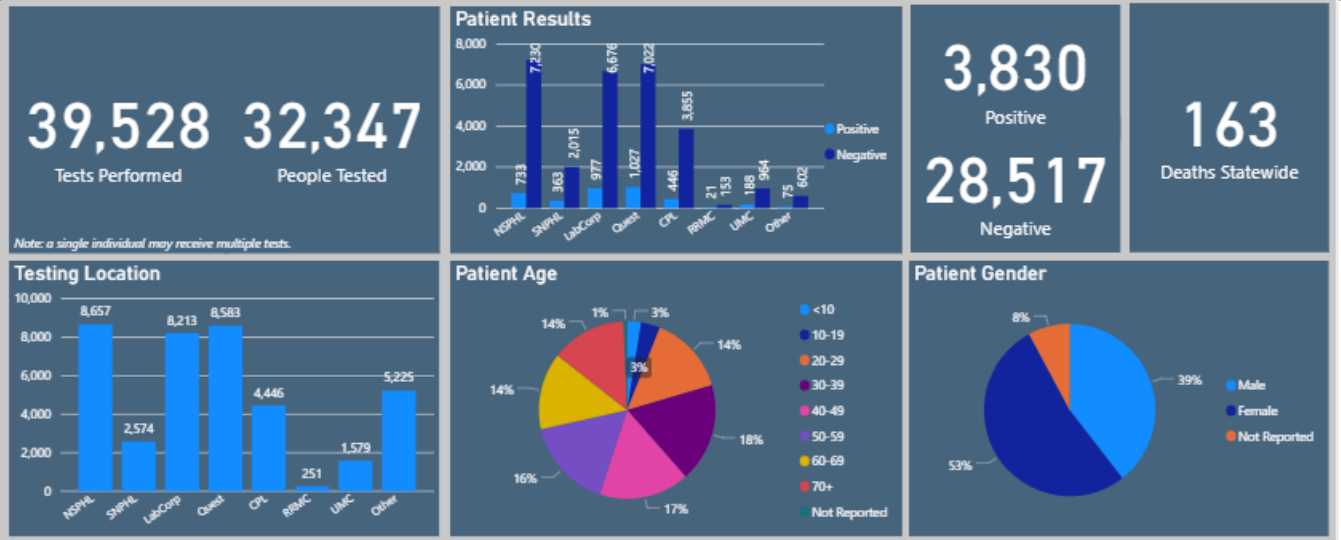

COVID-19 BY THE NUMBERS - NEVADA

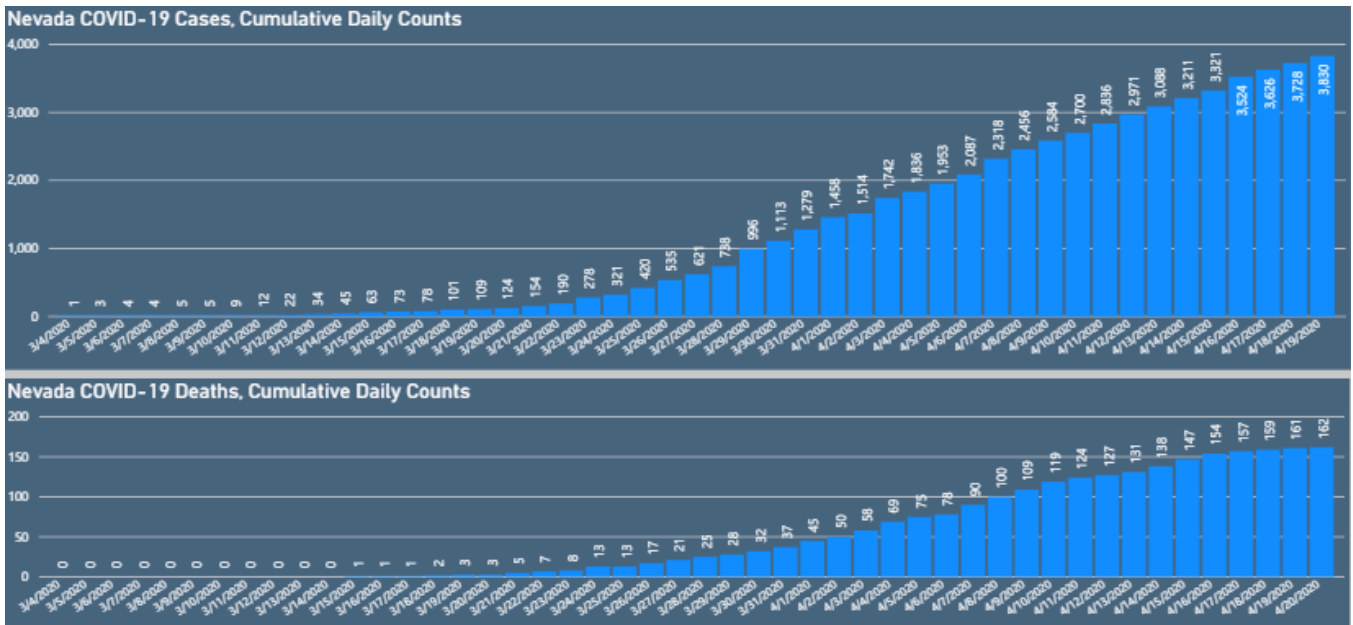


STATEWIDE HOSPITAL CAPABILITY STATUS*

STATUS OF FEDERAL REQUESTS

Test Kits	<ul style="list-style-type: none"> Nevada has received 3,000 reagent kits and 4,000 test swabs from HHS. <i>Note: Test kits acquired by community organizations, hospitals, private labs and entities through purchase or donation cannot be tracked by the State of Nevada.</i>
PPE <i>(Personal Protective Equipment)</i>	<ul style="list-style-type: none"> As additional PPE is acquired from federal agencies, donations and DEM purchases, it will continue to be distributed to the local health authorities and counties. <i>Note: The State of Nevada stockpile inventory of PPE has been distributed to the 3 Local Health Authorities (LHAs) and rural counties on a needs-based and population-based proportion based on the 2018 Census Bureau estimates.</i>
Other	<ul style="list-style-type: none"> Nevada received 150 ventilators from the SNS through FEMA on April 10, 2020. On Wednesday, April 8, Nevada received a loan from Cal OES for 50 California state-owned ventilators for three weeks at no cost. HHS will direct additional ventilators to the state approximately 72 hours prior to the anticipated need. FEMA delivered one pallet (340 lbs.) of hand sanitizer containers to Southern Nevada on Apr. 16 (equivalent of approximately 1,500-2 oz. bottles).

STATE OF NEVADA COVID-19 UPDATES

[APRIL 20, 2020] The Nevada National Guard began assisting the Washoe County Health District with COVID-19 sample collection capability on April 17th at the Reno-Sparks Livestock Events center. Nearly 30 medical support personnel are now assisting at the site with sample collection, contact tracing, call center operations, and general administrative support. The Guard is aiding in Governor Sisolak’s directive to expand testing throughout the State.

[APRIL 20, 2020] The Nevada Department of Employment, Training, and Rehabilitation (DETR) announced the successful update of their system on Saturday, April 18th. The update includes a new password feature that offers claimants the ability to reset their password online, 24 hours a day, seven days a week. The password recovery page is tailored to help users that previously had an account but forgot their password. To file for unemployment in the State of Nevada, filers can use the online application also available 24/7 [HERE](#).

[APRIL 20, 2020] Nevada Attorney General Aaron Ford facilitated a donation of nearly 500 mattresses by Aaron’s Inc. to multiple shelters in Nevada that have been impacted by the COVID-19. The donated mattresses will be delivered to shelters across the State, and help those that are experiencing homelessness or abuse. [APRIL 20, 2020] The Battle Born Medical Corps (BBMC) was created upon the signing of [Emergency Directive 011](#) by Governor Steve Sisolak on April 1, 2020 to assist Nevada Health Care facilities in bridging potential gaps in licensed healthcare workers caused by this pandemic. As of today, the BBMC has over 900 volunteers. The Nevada Department of Emergency (DEM) and the Nevada Public Health Preparedness (PHP) Program are now working with Nevada healthcare facilities to place these brave individuals that have volunteered. 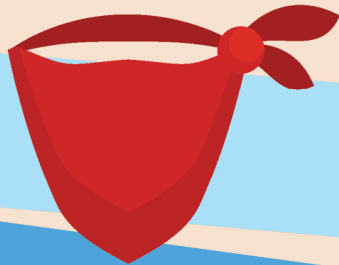
BATTLE BORN MEDICAL CORPS

FACE COVERINGS HELP PREVENT SPREAD

Melissa, a second grade teacher at Joseph Neal Elemengary, purchased materials for a student so they could participate in assignments.



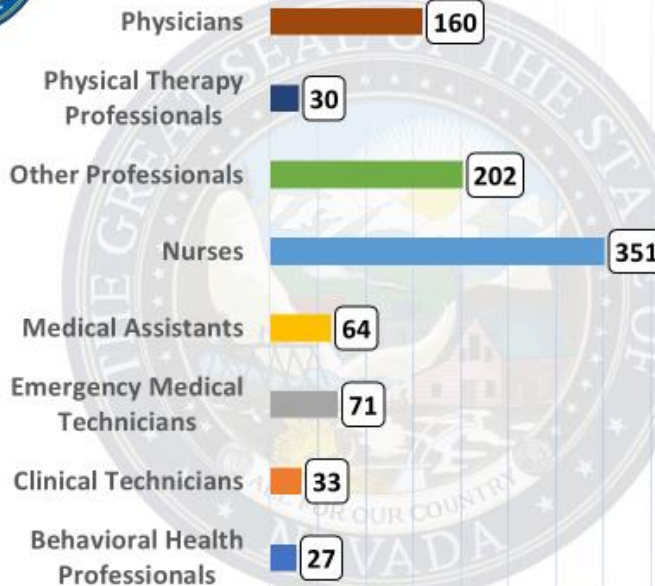

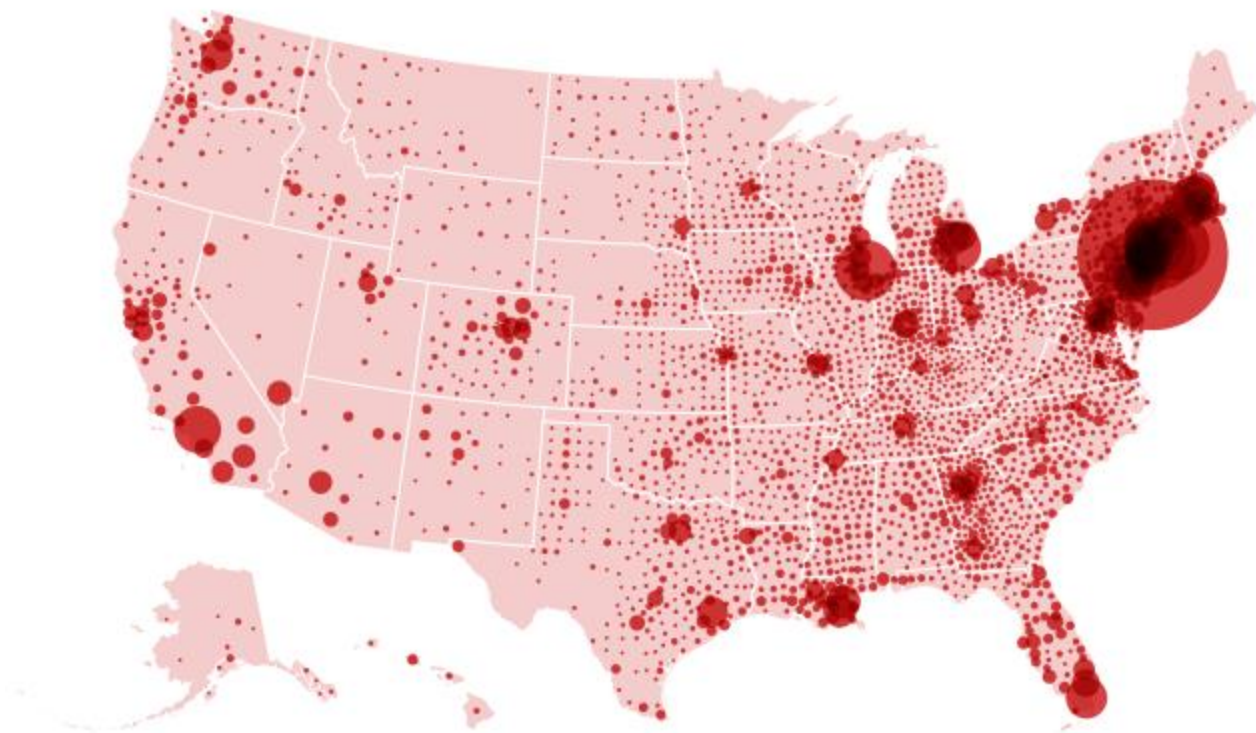

U.S. STATE DEPARTMENT

LEVEL 4 – DO NOT TRAVEL

The Department of State advises U.S. citizens to avoid all international travel due to the global impact of COVID-19. In countries where commercial departure options remain available, U.S. citizens who live in the United States should arrange for immediate return to the United States, unless they are prepared to remain abroad for an indefinite period.

At present the Department of State is making every effort to assist U.S. citizens overseas who wish to return to the United States. As the Covid-19 situation develops, our ability to provide such assistance working with commercial airlines or arranging for evacuation flights may become more limited or even unavailable. In recent weeks, commercial airlines have significantly reduced flight schedules and countries have closed airports and borders with little advance notice. If you wish to return to the United States, you should make arrangements to do so now and contact the nearest U.S. Embassy or Consulate for assistance as needed. There is no guarantee that the Department of State will be able to continue to provide repatriation assistance and transportation options to the United States may be unavailable in the future. If you choose to remain overseas, you should be prepared to remain where you are for the foreseeable future.

U.S. citizens who live abroad should avoid all international travel.

CENTERS FOR DISEASE CONTROL

LEVEL 3 – AVOID NONESSENTIAL TRAVEL

- Widespread ongoing transmission of a [respiratory illness caused by the novel coronavirus \(COVID-19\)](#) is occurring globally.
- **CDC recommends that travelers avoid all nonessential international travel.**
- Older adults and people of any age with serious chronic medical conditions are at increased risk for severe disease.
- There may be limited access to adequate medical care in affected areas.
- US residents may have difficulty returning to the United States.
- Travelers should avoid contact with sick people and wash their hands often with soap and water for at least 20 seconds. If soap and water are not readily available, use an alcohol-based hand sanitizer that contains at least 60% alcohol.
- All international travelers should stay home for 14 days after returning from travel, monitor their health, and practice social distancing.
