Cause	Cases
<b>Deaths Due to COVID-19</b> Official number of individuals who died from COVID-19 as stated on the official death record. There will be a delay - by state law, a death record must be filed within 10 days of the date of death.	68
Deaths Where COVID-19 is Not the Primary Cause Deaths that list something other than COVID-19 as the official cause of death.	8
<b>Pending Death Records</b> The number of deaths where an official death record has not been filed. Per state law, this can take up to 10 days from the date of death.	2
<b>Total</b> number of individuals who tested positive and died from any cause while infected with COVID-19.	78
Deaths of Individuals Presumed Positive  Deaths of individuals where COVID-19 was listed as the cause of death on the official death record, but there was not a positive test result. These individuals are presumed positive by the health care provider based on symptoms and/or exposure.	9
