

Coronavirus Disease 2019 (COVID-19) Situation Report

Palau Ministry of Health - External Situation Report 11 April 2020 - 09:00 PWT

GLOBAL SITUATION OVERVIEW

The Ministry of Health (MOH) is closely monitoring an ongoing pandemic of a coronavirus disease which is affecting over 180 countries globally. The World Health Organization (WHO) declared the outbreak as a Public Health Emergency of International Concern (PHEIC) on January 30, 2020, designated its official name as Coronavirus Disease 2019 (COVID-19) on February 11, 2020, and characterized it as a *pandemic* on March 12, 2020.

As of April 11, 2020:

- At least 1,694,954* confirmed cases of COVID-19 globally, including 130 in Guam, 11 in the Northern Mariana Is. (CNMI), 465 cases in Hawaii, 51 in French Polynesia, 18 in New Caledonia, 15 in Fiji, and 2 in Papua New Guinea.
- **117,247**** confirmed cases within the **Western Pacific Region**.
- 102,607* deaths reported globally 3,978** deaths in the Western Pacific Region, 4 deaths on Guam, 8 in Hawaii, 2 in CNMI.
- 376,102* people have recovered from COVID-19 globally.

PALAU READINESS AND RESPONSE

As of April 11, 2020:

- There are <u>NO SUSPECTED</u> or <u>CONFIRMED CASES</u> of COVID-19 in Palau.
- MOH Emergency Operations Center (EOC) activated on Jan. 22, 2020 to implement preparedness and response measures to minimize the risk of importation and potential local transmission of COVID-19 to Palau.
- Belau National Hospital (BNH) has reduced non-essential services and clinics and is prepared to receive and care for critically ill suspected cases.
- <u>BNH ventilators:</u> 0 in use, 8 available on-hand, 10 currently being procured, 18 total expected capacity.
- Polymerase Chain Reaction (PCR) testing equipment and COVID-19 test kits arrived on Apr. 1. On-island testing will be available within 2 weeks after equipment installation, calibration, and MOH personnel training is completed. Biosafety cabinet for laboratory testing and additional ventilators arrived on Apr. 9 via ship.
- Alternative Care Site (ACS) is currently being prepared to receive and care for critically ill suspected cases.
- MOH 24-hour COVID-19 Hotline activated for public inquiries: +680-488-0555.
- Health screening continues at Palau International Airport for chartered and private aircrafts; health screening at Malakal seaport continues for incoming vessels. Screening data:
- <u>Past 24 hours:</u> **0** flights screened, **0** travelers; **1** vessels screened, **18** travelers; **0** secondary screening.
- Since Jan. 23: 167 flights screened, 15,169 travelers; 37 vessels screened, 1,330 travelers; 327 secondary screening.
- All commercial air travel to Palau is temporary suspended as of Mar. 26 until further notice as airlines temporarily halt services. Air mail and cargo service continues on a weekly basis through chartered services.
- Executive Order No. 437 signed on Mar. 17, 2020 urging the collaboration of all government agencies in the COVID-19 response and extends existing travel restrictions until April 30, 2020.
- MOH issued a *Certification of an Unavoidable Public Health Emergency* for COVID-19 on Mar. 17, 2020.
- MOH has conducted COVID-19 briefings with special population groups including inmates at Division of Corrections.
- Ministry of Education issued directive on Mar. 31 to extend school closures until Apr. 17, 2020 to allow for further preparations for potential COVID-19 cases.
- The public is urged not to panic and to continue practicing public health measures to prevent respiratory infections:
 - Hand Hygiene: Frequent handwashing with soap and water or hand rub with 70% alcohol-based sanitizer.
 - Respiratory Etiquettes: Cover cough and sneeze with clean tissue or shirt sleeve.
 - Social Distancing: Avoid close contact with others (at least 6 feet) and stay home if you are sick.
