Novel Coronavirus

Infectious agent: *severe acute respiratory syndrome coronavirus2 (SARS-CoV-2)*

Situation Summary: In December 2019, Chinese health authorities identified an outbreak of pneumonia associated with a novel, or new, coronavirus which has resulted in thousands of confirmed cases in China.
