**Infectious agent:** *severe acute respiratory syndrome coronavirus2 (SARS-CoV-2)*

**Situation Summary:** In December 2019, Chinese health authorities identified an outbreak of pneumonia associated with a novel, or new, coronavirus which has resulted in thousands of confirmed cases in China.
