In the newest [Weekly Data Summary](#) Spotlight, we focus on Vermont COVID-19 cases among Black, Indigenous and people of color (BIPOC). There is a disproportionate number of BIPOC with COVID-19 in Vermont.

The summary gives you detailed Vermont data about cases among Black, Indigenous and people of color, including rates by county, sex and age. Compare rates of hospitalization, chronic disease and how they may be exposed to COVID-19, with white non-Hispanic people.

**Correction:** The colors on a pie chart on the slide provided in yesterday’s Daily Update (from page 33 of the Weekly Data Summary) were incorrect. There is no change to the data. BIPOC should be represented on the chart as purple, and white non-Hispanic as blue. This has been corrected in the summary available online.
