## Coronavirus Disease 2019 (COVID-19)



At this time there are three reported Wyoming cases.

The Wyoming Department of Health is closely monitoring the current coronavirus disease 2019 (COVID-19) outbreak situation and sharing recommendations.

We don't yet know exactly how easily COVID-19 spreads and how many people will experience severe illness. While we are facing a rapidly developing situation, the risk to most Wyoming residents remains low at this time.

The symptoms reported with this disease are familiar to all of us: fever, cough and shortness of breath. Steps that can help prevent the spread of such illnesses include: avoiding contact with sick people, staying home when sick, covering nose and mouth when coughing or sneezing and washing hands often and carefully.

## Travel Information

The Centers for Disease Control and Prevention (CDC) recommends avoiding all nonessential travel to **China, Iran, most of Europe, the United Kingdom and Ireland and South Korea**. CDC also says older adults and those with chronic medical conditions should consider postponing nonessential travel.

CDC also recommends travelers, particularly those with underlying health issues, avoid all cruise ship travel worldwide at this time.
